and behoof of the said Abraham Thompson
his heirs and assigns forever, have bargained and
settled & claims of all person or persons whatever

Price, and with full power to transact all and
every the matters and things which the said Samuel
Price was in the said Power of Attorney empowered
to perform and execute.

said Samuel Price hath made and caused constituted
authorized and empowered Joseph Taylor Taylor
of Granville County in the said State of North
Carolina in this place and stead of him the said
Samuel Price to do perform and execute all the

aforesaid in touching and concerning the estate of
Jesse Benton of Orange County in the said State of
North Carolina deceased, and also enter & take
