 given in Manner and form following that is
 to say first I give and bequeath unto my dear
 and well beloved wife all my home plantation
 with all my moveable furniture therein during her
 Natural life, and afterwards the said plantation
 to be Divided between my two sons, the North half
 to my eldest son Thomas Loyd Hogan and the
 south half to my youngest son who is not yet named
 and further I order and decree that all the Estate
 of Horses, Cattle and Household Furniture with
 the still and rooms and all other things mentioned
 in a Deed of Gift, given to me by Hugh Thomas
 Loyd, that after the said Thomas Loyds Death
 I have all to be sold and Equally Divided
 amongst my daughters - And further I devise
 that my riding Saddle should be given to my son
Thomas, and also my Gun be sold to Stephen
the present captain, and in order to put this
 my last will into execution I ordain my dear
 and well beloved friend John Hogan &
William McCauley to act for me and in my
 stead to see that this my last will and
 testament may be fully put into execution

 Thanks be to Almighty God for the same & Calling
 to mind the frailty of my body & knowing that it
 is appointed for all men once to die, do make this
 my last will and Testament, that is to say princi-
 pally and first of all I give & recommend my body
 & soul into the hands of Almighty God that gave it
 my body I recommend to the Earth to be buried
 in a decent burial at the discretion of my
 Executors, Nothing doubting but at the General
 Resurrection I shall receive the same Again by
 the power of almighty god. And as touching
 my worldly Estate as it hath pleased God to
 give me with in this Life I give (Devise) Dispose
 of in Manner and form following -
 First I give to my beloved son John Morgan
 one shilling Sterling, Then I give and bequeath
 to my beloved son Hardy Morgan one shilling

Sterlingth Item I give & bequeath to my beloved
Daughter Anne Hart one Shilling Sterling.
I lend to my beloved Daughter Sarah Yeagan
During her Natural Life one Negroe girl
named Lucy & one Negroe boy named Chance
And at the death of my beloved Daughter
Sarah Yeagan, I give & bequeath to my beloved
Grand Daughter Charlotte Yeagan the above
Mentioned Negroe girl Lucy & the above Men-
tioned Negroe boy named Chance to her & her heirs
forever and if the above mentioned Charlotte
Yeagan should die without Lawfull heirs
Lawfully begotten on her body, my desire is
the above mentioned Negroes Lucy & Chance
with their Increase should return to the
next surviving heir of her family. Item
I give & bequeath to my beloved Daughter Sarah
Yeagan all my real & personal Estate & the
increase with all the profit and Interest
arising therefrom during her Natural
life and then my desire is that it & all
and every of the said Estate should be divided
Amongst the surviving Children she has by
Benth Yeagan -
Now I constitute make & ordain
Benjamin Yeagan and Daniel Hogan
the whole & sole Executors of this my

last will and testament And I do hereby Will
Disallow, Revoke & Disannul all and every
the former Testaments wills Legacies beques-
and Executors by me in any wise before named
Willed & Bequeathed, Ratifying and confirm-
ing this and No other to be my last will &
Testament in Witness whereof I have hereunto
set my hand & Seal this twentieth day of
October in the year of our Lord one thousand
seven hundred & eighty five,
