 in the year of our Lord one thousand seven hundred and
 sixty three Isaac Stantefor of Orange County and State
 North Carolina being very sick of Body but of perfect
 sound memory thanks be given unto Almighty God
 for the same and knowing the Mortality of the Body
 and it is appointed for all men once to die I do
 hereby constitute Ratify and Confirm this my
 last will and Testament that is to say I first of all
 recommend my soul unto God into the hands of Almighty
 God who first gave them He be praised in a Christian
 like manner at the Discretion of my Executors hoping
 in the Resurrection of the Dead to forgive me of my
 sins through Jesus Christ our Lord.
 And I do hereby give and bequeath of the same in the
 following manner and form

First of all I give and bequeath unto my loving wife
 Sarah Stantefor all my moveable property
 such as my household furniture Wools cattle Hogs
 and Sheep and all other such property I am possessed with
 at this time I also give unto my eldest son Ephraim
 Stantefor twenty five pounds current money when there
 is a Debt made for my land I now live on I give also
 to give unto my Daughter Sarah Rogers the third
 and my wife Sarah on after her decease and after her
 Decease to her Daughter Sarah Rogers I desire to give
 unto my Daughter Rosamond Rogers one cow after
 there is a Debt made for the Land.
 I also give unto my son Joshua Stantefor my plantation
 which I now live on with two hundred acres of Land including
 the improvement where on I now live

I also give unto my son Israel Standiford one hundred
 acres of Land called by name of William Cohen place
 that my son Joshua Standiford should make him
 to the said when he the said Joshua Standiford obtain
 a Deed himself and if the said Israel Standiford should
 to the said when he the said Joshua Standiford obtain
 a Deed himself I also give unto my two Daughters
 Mary Standiford and Elizabeth Standiford one hundred
 acres of Land Beginning on the Water Works
 adjoining Thomas Gaynes to the said William Cohen
 making out one hundred Acres my above is the
 my son Joshua Standiford shall make a Deed
 unto my two Daughters Mary & Elizabeth
 when he obtains a Deed I also give unto my Grand
 son Turner son of Ruth Turner wife of William
 Turner Eighty Eight Acres of Land lying on
 the North Side of William Ricketts part of the same
 on Benjamin Pileas land when my son Joshua obtain
 a Deed I also desire one hundred Acres of Land
 to be sold when a Deed is obtained to pay of
 Legacies. I also give unto my son Benjamin Standiford
 forty Shillings Current money when a Deed
 is obtained for the Land. I also give unto
 my Daughter Casander Weldon forty
 Shillings Current money when there is
 a Deed obtained for the Land. —
 And I do appoint my wife Casander
 Standiford and my son Joshua Standiford
 as Executors of this my last will and
 Testament Prooving and disavowing

all other and former wills and Testaments by
 me made as witness I have hereunto set my
 hand and affixed my seal the day and
