appoint my Brother, Solomon Thomas of the County & State
aforesaid my true & lawful attorney to act for me in the
State of North Carolina, & to settle all my business there,
by deed or otherwise, as my said attorney may think
proper, to my advantage, or to appoint any other person
to act under him, & to do whatever he may empower him
to do in the premises, which power I do hereby ratify &
confirm, and in all cases wherein concerns my business,
I do hereby ratify & confirm whatever my said attorney may
do or act - In Witness whereof I have hereunto set my
hand & affixed my seal this 17th day of July 1799
