This Indenture made the sixth day of September in the year of our Lord one Thousand Eight hundred and Two Between Sam^l Smith Chairman of the County Court of Person County and State aforesaid on behalf of the Justices of the said County and three successors of the one part and Sarah Wanhook of the Other Part Witnesseth that the said Sam^l Smith in pursuance to an order of said County Court made the sixth day of September and according to the directions of the act of Assembly in that case made and Provided doth first place and bind unto the said Sarah Wanhook an Orphan Name: Thomas Cozens now the age of seven years with the said Sarah Wanhook to live after the manner of an apprentice and servant until the said apprentice shall attain to the age of twenty one years: during all which time the said apprentice his Mistress faithfully shall serve her lawful commands every where readily Obey; he shall not at any time absent himself from his Mistress service without leave, but in all things as a good and faithful servant shall behave towards his said mistress And the said Sarah Wanhook doth Covenant promise and agree to and with the said Samuel Smith that she will teach and instruct or cause to be taught and instructed the said Thomas Cozens to learn the art and mystery of a planter and that she will constantly find and provide for said apprentice during the term aforesaid sufficient diet washing lodging and apparel fitting for an apprentice, ~~and also~~ ~~and~~ ~~also~~ ~~all~~ ~~other~~ ~~things~~ ~~necessary~~ ~~both~~ ~~in~~ ~~substance~~ ~~and~~ ~~in~~ ~~health~~.
