This Indenture made 2^d day of Decem^r in the Year of our Lord one thousand seven hundred & Ninety Nine, Between John Gwin Esq^r in behalf of the Justices of the County of Prince & their Surveyors in Office of the one part & Richard Hamlin of the other part Witnesseth that the said John Gwin Esq^r agreeable to an Order of the said County Court made the day & date above Written, doth please & bind unto the said Rich^d Hamlin, an Orphan of the age of 18 Years by the Name of John Fuller, to live after the manner of an Apprentice & servant until he shall attain to the age of 21 Years, during all which time his said Master faithfully shall serve, his lawful Command every where Gladly obey, he shall not at any time absent himself from his said Masters Service without leave but in all things as a good & faithful servant shall behave towards his said Master, & he the said Rich^d Hamlin doth Covenant, Promise & agree to & with the said John Gwin Esq^r that he will Teach & instruct or cause to be Taught & instructed the said John Fuller according to Law to read write &c. also the art & mystery of a Planter, & that he will constantly find & provide for the said Apprentice during the term above said, sufficient diet, washing, lodging & Apparel fitting for an Apprentice & servant, & also all other things necessary both in sickness & in health - In Witness whereof the Parties to these presents have Inseparably set their hands & Affixt their seals the day & date above Written Sign Seal & Delivered
