Know all men by these Presents that I William Harrelson of Person County & State of North Carolina, for the Consideration of the sum of Twenty five Pounds fourteen Shillings & Four pence Current, to me in hand paid by John Rogers of the State of North Carolina, the receipt whereof I do hereby Acknowledged, have Bargained sold & Delivered & by these Presents do Bargain Sell & Deliver unto the said John Rogers his heirs & Exec^t to him or his Assignee, one Negro Woman named Ruby, to have and to hold, the said Negro until the said John Rogers his heirs & Assignee forever & I the said William Harrelson for my self my heirs Exec^t & Assignee shall & will Warrant and Indemnify the said Negro unto the said John Rogers his heirs & Assignee forever, In Waccamaw whereof I have set my Hand & Seal the 5th day of June 1799

Know all men by these Presents, that I Daniel Clayton of the County of Person and State of North Carolina, have Constituted make & appointed, & by these Presents do constitute make and appoint my trusty & loving friend Rubin Long of the County of State aforesaid my true & lawful Attorney, for me & in my Name & stead & to my use, to ask, demand, sue for, buy, recover & receive, at such sum & sum of money, debts, Rent, Goods, Wages, Duty, attorney, and other Demands whatsoever which are or shall be due, owing, payable, & belonging to me, or attained from me in any Manner of way or means whatsoever by the Executing or doing of the State of my late Grand Father Rich. Colleton late of Rutherford County State aforesaid Dying and granting unto my said Attorney, by these Presents my full and whole Power, Strength and Authority, is & about the Premises to have, use & take, at lawfull way & manner in my Name for the Recovery thereof, & upon the receipt of any such Duty, Duty or sum of Money aforesaid Acquittances, or other sufficient Discharges, for me & in my Name, to make, seal & deliver, & generally all and every other act and thing and things, Law or Lawes, in Law whatsoever, and full & Mystery to be done in & about the Premises, for me & in my name to do execute & perform, as fully, exactly & amply, to all intent and purpose, as I myself, might or could do if I were personally Present, or as if the same required more special authority than is herein given; and I declare one or more under my name for the purpose aforesaid to make & constitute, Regis & Pleasur to Revoke, ratifying, allowing & holding, for firm & effectual, all & whatsoever my said Attorney shall lawfully do in and about the Premises, by virtue hereof.
