The Will of Benjamin Barrow, 1807, Pitt County. NC Supreme Court Case #301, NC Archives and History

In the name of God Amen, I, Benjamin Barrow of the county of Pitt and State of North Carolina being sick and weak in body but of sound mind and memory thanks be to Almighty God for the same do make this my last will and testament in manner and form following, viz--

Item. I give and bequeath unto my loving wife Honer Barrow one negro woman by the name of Rose, one man by the name of Lewis.

Item. I give unto my wife one riding chair and horse sorrel, two cows and calves, two sows and shoats, two beds and furniture, a table, one chest and the rest of what furniture which I am possessed of and the remainder of my stock I give unto my grandson Benjamin Forbes to pay what debts I owe at present.

Item. I give unto my granddaughter Polly Forbes one negro girl by the name of Fanny. Likewise I give unto y daughter Sally Forbes one negro girl by the name of Violet to them and their heirs forever.

Item. I nominate and appoint my loving grandson Ben Forbes to be my sole executor to this my last will and testament disannulling all and every will or wills by me made, signed, sealed and

delivered September 5th 1807 in the presence of us. /a/Tobias Butler, Frederick Hardison

Daughter, Sarah Wilson, 4 negroes, one negro girl called Centhy, one negro girl called Sarah, one negro woman called Eady and Eady's youngest child, one bed and furniture to her and her heirs and assigns forever.

Daughter, Elizabeth Kilpatrick, 4 negroes, girl named Cherry, girl named Betsy, woman called Chainy and Chains, the youngest child, one bed and furniture to her and her heirs forever.

Daughter, Louis Smith negro girl, Phillis, one negro girl called----, one negro woman called Ertha and Ertha's youngest child, one bed and furniture to her and her heirs forever.

Daughter, Rachel Burney, 4 negroes. One negro boy called Tiny, one negro girl called Jemima, and one negro boy called Jackson, one negro girl called Grissy and bed and furniture to her and her heirs and assigns forever.

Granddaughter, Eliza Woote, one negro girl called Roda.

Grandson, Counsel Wooten, one negro by called William.

Son, John H. Burney all my lands and plantations on Clay Root and Swift Creek; also all my negroes that I possess except those mentioned above, all my horses, sheep and cattle, also one riding chair and harness, all my farming utensils, household furniture, my notes and cash, that I leave at my death to him and his heirs and assigns forever.

Son, Bryan Burney fifty cents, one bed and furniture to him.

Son, Lewis Burney fifty cens, one bed and furniture.

Son, Simon, fifty cents, one bed and furniture.

Executors: Friends, William Pugh and John Burney. /s/Simon Burney, Sr.

Wit: William Burney, Henry BUrney, Samuel Smith. Probated May Session 1829
