Thirdly, I leave and bequeath to my son Andrew Thompson fifty Acres of land Lining together line to the only use of him the said Andrew and his heirs and assigns forever. —

Fourthly, I will and bequeath to my Daughter Elizabeth Thompson her heirs and assigns forever one horse & creature worth fifty Dollars and one Cow and calf worth ten dollars half my patten One Iron pot my Dressers & also one bed and furniture. —

Witely I will and bequeath to my two sons Joseph Thompson & W. Thompson all my other lands and property whatever after the above mentioned legacies and debts are paid to the only use of them the said Joseph & William their heirs & assigns forever, And I do here by nominate and appoint Joseph Deagan & S. Henderson my executors of this my last will and Testament. Revoking & annulling all the will or Wills by me before made and ratifying & confirming this my last will and Testament in Writing whereof I have herunto set my hand and seal.
