KNOW all men by these presents that I Charles Mullins of the
 County of Randolph and State of North Carolina being weak in
 Body, not of sound disposing mind and memory, do make and cause
 these presents to contain my last Will and Testament in manner
 following to wit: First I give and bequeath to my Daughter Mary
 Mullins Two Feather Beds and one Chimney, One Glass Wheel, one
 Cotton Wheel, One Bed, One Walnut Table, two Small Iron Pots and Hooks
 3 Sitting Chairs, One Iron Kettle, One Bible, One Brown Book, One Iron
 Book, One Short and large Catechism, One large Washing Tub, and
 Piggins, One Cow and Calf, One Cow and five Hens to her and
 her disposal.

2nd I give to my Daughter Margaret Mullins One Feather Bed
 and Chimney, One Chest, One Dresser all the Pewter Crockery,
 China and Earthen Ware, One Glass Wheel, One Cloth Loom and
 all the Utensils thereto belonging, One Large Iron Pot, One Small
 Dutch Oven, Two Sitting Chairs, One Bible, One Mother Catechism
 and one Testament to her and her disposal.

3rd I give and bequeath One Feather Bed and furniture to my
 Grand Son Elebourn Ryan and his heirs forever.

4th I give and bequeath to my Son William Mullins Thirty
 acres of Land to be laid off on the South East end of the old
 Tract of Land whereon I now live, to him and his heirs forever
 Also I give him my Smiths Dice to be at his disposal.

5th I give and bequeath to my Two Daughters Mary and Margaret
 Mullins the Balance of the old Tract of Land whereon I now live
 to them and their heirs forever and be equally divided in Value
 between them, I also give a Note of hand on Leonard Marsh
 for Fifty two Dollars & 50 Cents to my two said Daughters to be

6th I give and bequeath to my Son Hugh Mullins my other Tract of Land called
 the New Entry Lying in Guilford County to him and his heirs forever, Also One
 Cow and Calf, One Bed and Chimney, 1 Dutch Oven, One Waggon all of which
 I have before him with, I likewise give my Son Hugh Mullins One Broad Saw,
 one Drawing Knife, The Balance of my Books to be equally divided between my
 two Sons William and Hugh Mullins.

7th I give to my Son John Mullins One Dollar to him and his disposal
 I give to my Daughter Nancy Ryan One Dollar to her and her disposal
 I leave the balance of my Estate to be sold by my Executors and after my
 just debts be paid the balance I give to my Son Hugh Mullins and lastly I
 appoint my Son Hugh and Daughter Mary Mullins Executors to this my
 last Will and Testament, in Witness whereof I have hereunto set my hand
 and Seal this 5th of June 1819.
