bequeath doleful, and to my daughter Mary Jones  
I give five dollars and unto my son Joseph Arledge  
I give all the plantation when I live & be dead  
and all the land that I am lawfully possessed of for her  
and unto this my last will & Testament I nominate  
constitute and appoint my loving son Joseph Arledge  
and my worthy friend Joseph Vestal my Executors
