In the Name of God Amen I Elizabeth sister of the County of Dumfriesshire in the Kingdom of Scotland being in a bad state of health, but of sound and perfect mind and memory, do this Twenty third day of November in the Year of our Lord one thousand eight hundred and Twenty one, Make and Publish this my Last Will and Testament in Man following, that is to say, I first Give & bequeath to my dear daughter Mary Ferguson Allen the following Negroes to wit, James, London, Lyle, Lucy, Maria, Calista, Little London, Miranda, Polly, Anne, Nelson, Demise and Nancy with all their increase and at her death I Give the said Negroes to such Child or Children of my said daughter Mary as shall be living at the time of her death, and if she should die leaving no Child or Children at her death, I Give all the above mentioned Negroes with all their increase aforesaid to my Nephew of Kin as shall be living at her death - all the rest of my Property I Give to my said daughter Mary, except such as is hereinafter disposed of. Then I Will and direct that the amount due me in bonds and such sum as may be due from my Father's Estate together with the amount of Cash I have, shall be laid out in bank stock, to be purchased in such bank as the Trustees hereinafter appointed, shall purchase shall think best: and I Give to the said Trusties the interest or dividend that may be declared from time to time on the said bank stock in Trust for the use of my said daughter Mary to be paid to her in such way & manner as the aforesaid Trusties may think meet to her advantage & benefit, and at the death of my said daughter Mary I Give the said bank stock purchased as aforesaid to her Children, but should she die leaving no Child or Children I Give the said bank stock to my next of Kin who shall be living at her death - I appoint my Brother John Hapley, Alexander Gray & James Henderson Executors to carry into effect this part of my Will, and it is my Will that my Executor hereinafter appointed, as soon as the debts owing to me are paid and all claims of my Estate made, pay over to the said Trusties such amount of bank as may be due from him, to be held as aforesaid in bank stock by them

 sons and Daughters namely Henry William Nathan and Harney and John and
 Elizabeth Harney and Sally also I give my daughter Mary such that she has of John
 Wilson one hundred Dollars to be divided Equally among her heirs as the law is
 also I give my son John my plantation which I have lived after the death of my beloved wife
 or her heirs and what until that time also that on land of land of 200 acres
 in Chatham sit lying on the banks of Rocky River to be sold and also one tract sit
 in Jefferson County Chatham County also one Tract of land known as my own bottom and
