I Now live on Equally Divided Abraham to have his half of the
South End of the land with all my tools and Plantation Wharf
to them and their heirs for Ever allowing my Wife the third of the
profits of the same During her life time or Widowhood Then I Give
my Loving Wife Susanna Bech Her Bed and furniture for her Bed
and three Pound for Ever also have money for Ever and also the third part
of the Plantation and Stock Haulp and use of the house and House hold
furniture for her life time or Widowhood Then I Give Two
Daughters Susanna and Lydia Bech the half of the Stock and House
hold furniture Equally Divided Between them at my Wife's Death
or Widowhood to them and their heirs for Ever Then I Give my two
sons Abraham and Jesse Bech the other half of the Stock and House
hold furniture Equally Divided Equally Between them at my Wife's
Death or Widowhood to them and their heirs for Ever.

It is my Will that all the Tools and goods Be kept for the use of the
family it is my Will that all that my two Sons Abraham and
Jesse Bech Be School out of the money that I have in my hands
and it is my Will that if either of my two Sons Abraham or Jesse Should
Die Before they Come of Age then the Surviving one to have all
his Share and also the girls Susanna & Lydia the Surviving one to have
the others Part Then I Give my two Sons Abraham and Jesse my
Wearing apparel made and some unmade I leave under the same
goods and Chattels all in my hands not above mentioned in the
hands of my Executors.

under the Care of Two Guardians my just Debts paid it is my
Will that all my goods and Chattels Be Paid and on Account
untill my Executors Come of age for the Use of the family
I do Hereby constitute my Trusty Son Jesse Bech my Sole Execu-
tor of this my Last Will and Testament appointing him under
the Care of William Nuffell and David Jackson Neary Bewch-
ing and Disannulling all former Wills and Testaments In
Witness Where of shall and Every Part of the above said Will and
Testament I have Hereby Set my hand and Seal this 11th

funeral Charges to Be paid by my Executors Hereafter to Be
Named 2^d I Give to my grand Son Stephen Harlan the Two
Hundred Acres of the Land I now live on Including all Imprem-
ment to him his heirs and assigns and no more 3^d I Give to my two
Sons Benjamin Bufon and Isaac Bufon and to their heirs and
assigns the Remaining part of the said Land to each and Equal
part and for Benjamin to have the East and Isaac to have the West
End 4th I Give to my son Benjamin two fether Beds and all the fether
furniture Belong there unto I Give to my son Isaac the fether bed
I Now ly upon and all the furniture Belong there unto
