I Margaret Hendricks of N^c Carolina & County of Rowan being very weak of body but of a sound mind & memory & thanks be to God for his mercies & calling to mind the mortality of the body knowing it is appointed for all men once to die & after death to come to Judgment; I recommend my soul to God through our Lord Jesus Christ & my body to the earth to be decently buried, in a christian like manner at the discretion of my executor hoping to have both soul & body united at the general resurrection by the mighty power of God and as touching my worldly goods as it had pleased God to bless me with in this life. I give & dispose of in the following manner viz.

First I give & bequeath to my son David Hendricks that bond that is in Edwin Alexanders hands, in Salisbury for him to satisfy himself for twenty five pounds then the remainder of this bond to be equally divided amongst my three children & likewise I give to David Hendricks one feather bed & furniture & likewise two shovels.

Secondly I give & bequeath to my son Henry Hendricks one cow & likewise one heifer, to his daughter Margaret & likewise one log chain & likewise seven head of hogs & one walnut chest & a pair of stillatons

Thirdly I give & bequeath unto David Baity & Sarah his wife severally eight acres of land upon the waters of Dutchmans creek & likewise one walnut table & likewise six head of hogs, four head of sheeps to be equal divided bet David Baity & Henry Hendricks.

Fourthly I give & bequeath to my grandson Henry Baity one hundred & twenty five acres of land upon the waters of Dutchmans creek him & his heirs, & for my other joint party to be sold at public sale, & after my funeral charges are paid & just debts, out of it, then the remainder to be equally divided amongst my grand children & I likewise constitute & appoint my son in law David Baity my whole & sole executor of this my last will & testament revoking & making void all wills by me heretofore made certifying & confirming this & no other to be my last will & testament. In witness I have hereunto set my hand & seal this 11th Day of Septor 1800.

I bequeath to Lenny M'Hoys daughter to Joseph Hays the sum of ten dollars in money Item I give & bequeath all the remainder of my money to William & Catharine Hays to be equal divided between them & I do nominate by these presents & appoint W^m & Joseph Hays executors to this my last will & test: in witness whereof I the s^d Andrew Hays have hereunto set my hand & seal this 10th Day of Sept^r: 1806.

Isaac Hitchcock have to this my last will & testament set my hand & seal the day & year above written.

Viz.

First of all I give & bequeath unto my beloved sons Oliver Henderson & Elijah Henderson all the tract of land I now live on, to be divided by the north fork of the branch that runs through my plantation to the old bridge then with the conditional line to Drailsbacks Loney the south side of the said branch to Oliver Henderson & the north side of
