I George Shollabock of Rowan County in the State of
N^c Carolina being very sick but of sound senses & memory
thanks be to God for the same knowing that it is appointed
for all men once to die, I do for the purpose of settling
all my affairs with every person & to dispose of my
worldly estate, wherewith ~~God~~ God has blessed me in this
life do make & ordain this to be my last will & testament
in the following manner & form.

First. It is my will & I do direct that my wife Susanna
may retain & keep in her possession all such of my
household and plantation articles, horses & cattle or
any stock of mine for the support of her & my children
during the time she remains my widow but in case
she should marry again, or in case of her death in either
of those cases, I do direct that my hereafter named executor
shall sell all personal estate & shall divide the whole
amongst my wife & children, share & share alike, if
in the case of her intermarriage, but if in the case of her
death of my wife Susanna I do then direct that both my
real & personal estate be sold by my executors & equally
divided amongst my children & do give hereby my hereafter
named executors full power to convey my real estate
to the purchasers for ever.

Secondly. I do direct that all my just debts shall be
paid & also my funeral charges & do further & hereby

constitute my friend John William my executor, and
allow this & no other to be my will & testament in
witness whereof I George Shollabock have hereunto
set my hand & seal this 22^d day of January 1804.

In the name of God amen! I Andrew Hunt of
the County of Rowan & State of N^c Carolina being at
this time in perfect sound disposition mind & memory
thanks to God for it - Calling to mind the mortality of the
body - I have thought of it & do make this my last will
& testament - that is to say first of all I give & recommend
my soul into the hands of God that gave it & my body to
the earth to be decently buried at the discretion of my
executors to be hereafter mentioned, & touching such
worldly estate as it had pleased God to bless me in this
life I give demise & dispose of in the manner & form
following - first my will is that all my just debts be
paid then I first give & bequeath to my beloved wife
Lucy one horse she to have her chair & one bed & furniture
I also bestow unto her all my farm with all the farm utensils
& all my stock of every kind & all my household furniture
that is thereon belonging or so much thereof as may be
necessary to support her & all my three children, Andrew,
Patty & Giles that is under age, while she remains my widow

For her natural life time then I give & bequeath all that part of my land lying on the north side of cedar creek with half the water of the said creek or as near as may be to my sons Henry & Andrew to be divided by a line beginning at a forked maple tree standing on the north bank of said creek at the head of the beaver pond running thence north course untill it strikes Thomas Eckling & all that part of my land lying on the south side of beaver creek including my dwelling house & other improvements I give & bequeath unto my son Giles & after that part of my land lying on the north side of beaver creek is divided by the above mentioned line, the west part of it is to belong to Andrew & the east part to Henry - I also give & bequeath unto my son Andrew one black horse colt with a saddle & bridle - then at the expiration of my widows widowhood or her natural life my will is that all & every part of my property then remaining shall be sold & equally divided except my land & those of her articles already mentioned amongst all my children sons & daughters, John, Charles, William Henry, Andrew & Giles as well Mary Lucy Elizabeth & Polly observing what my married daughters are already had of me, so as to make each of their share of my estate equal, if my executors should conceive there should be any part of my stock or any other property that should be necessary for the support of my widow & three small children my wish is that it will

be sold & the money taken care of untill a division should take place, I require my executors to give my son Andrew six months schooling & my son Giles one year schooling out of my estate - also I leave eight Dollars out of my estate to be paid into the hands of the Deacon of the church at Eatons meeting house for the use of the church at the death of my widow. I ratify & confirm this & no other to be my last will & testament & I likewise constitute & ordain my son John William & Henry to be my sole executors to this my last will & test. In witness I have hereunto set my hand & seal this 13 day of February 1801

I John Harwood jr. of the County of Rowan & State of N Carolina being of sound & perfect mind & memory blessed be God do this 11th of April AD: 1805 Make & publish this my last will & testament in manner following that is to say first I give & bequeath to my beloved wife Esther my land & all the rest of my personal estate to her during her life and what is left of paying my just & honest debts. Secondly I give & bequeath my land to be equally divided betwan my two sons John Harwood & Esquire Harwood to be at their sole will & disposal at their mother decease.
