Also I have made a deed of Gift of a bay mare to my beloved son John therefore she shall not be esteemed any part of my Estate And I do hereby utterly revoke & disannul all & every other former Wills Testaments and Legacies Requests & Bequests by me in any wise before made writing and bequeathing ratifying & confirming this & no other to be my last Will and Testament In witness whereof I have hereunto set my Hand and Seal this twenty fifth Day of October in the Year of our Lord one thousand seven hundred & seventy two.
