Being a sound and perfect Mind and memory Blessed be God
On this happy first day of January in the year of our Lord
One thousand seven hundred and seventy six Make and publish
This my last Will and Testament bearing following that is
To say.

First, I Give and Bequeath to Sarah my beloved Wife full possession
and peaceable Enjoyment in the full and entire in Conjunction
with my own Estate, all my tract of land whereon I now live
during her Natural life. Also as her absolute property I Give
and Bequeath the whole of my household Furniture (Which my
Wife called Blackboard and the covered and Boned breeding mares, also
One half of the remaining horse creatures, also one half of the
horned cattle except those hereinafter bequeathed to my Daughter
Margaret. Also the sole Right of disposing of all my other
also before paying all my just debts (including quittance
and funeral charges jointly with my son David) myself
& all the cash I have at my death except five pounds and the
Value of a bed furniture Saddle herein after bequeathed.

To my son David I Give and Bequeath a Right of possessing and
peaceably Enjoying. Jointly with his Mother all my
Tract of land hereinafter whereon I now live during his
Natural life, also as his absolute property, I Give and bequeath
with the remaining half of the horse creatures above mention
ed, likewise the whole of my plantation tools wearing
a pair of well and riding saddles also the remaining half of
cash I have at my death except one half of the
Value of the bed furniture saddle and five pounds
above mentioned.

To my Daughter Margaret I Give and Bequeath all then
of my horned cattle generally named for and
claimed by her.

To my Daughter Sarah, I Give and Bequeath all the

Remaining half of the horned cattle herein first above
mentioned. Also a fathers bed, furniture bequeathed and was
equal in Value to those lately provided for my Daughters
Margaret, to be provided at the expense of her mother and
Brother David.

To my Grandson William Morrison, I Give and bequeath
Five pounds to be paid by his Grandmother and Uncle
David herein above mentioned. I Give and bequeath
But after the death of my beloved wife and son David
my land and premises herein above mentioned shall
be divided and the Valuation thereof equally divided amongst
all my children. I Give and bequeath that my Grand-
son David and all his Estate shall be Guardian of his mother and my worthy
Friend Joseph Sted.

Lastly, whereby make and ordain my beloved Wife and
my worthy friend Joseph Sted Executors of this my
Last will and testament. In witness whereof I the
Andrew Miller have to this my last will and testament
Set my hand and seal the day and year above written
