I give & devise to my son Warren Roberts the tract of land containing thirty one acres & one half whereon I now live & also one hundred acres of land where my mill stands on Polk's creek also 200 acres of land I purchased of William Moore to him & his heirs forever also the profits arising from my negroes stock & household & furniture which will be more than will maintain my wife at her discretion I give & devise to my son Josiah Roberts one tract of land purchased of Thomas Carson known by the name of Millers place also one tract of land containing 60 acres I purchased of John Ford to him & his heirs forever.

It is my will that my plantation on Country line creek in the County of Caswell be sold & the money arising therefrom together with all the residue of my estate to be equally divided between my son Thomas Roberts & Josiah Roberts, my daughter Polly Harvill Molly Moreton, Judith Eymond & Phoebe Richmond Nancy Roberts & Betsey Roberts daughter of my son William Roberts jointly to be considered to have a share provided that it shall be considered that Judith Eymond has received ninety pounds Virginia money already.

And for the performance of the above my last will & test I do appoint my beloved wife Phoebe Robert my son Warren Roberts & my true friend John Linton executing of this my last will & test, as witness I have hereunto set my hand & seal of Jany 1802.

I Deborah Biles of the State of North Carolina of Rowan County being in perfect health of Body & of perfect mind & memory thanks be given unto God I calling unto mind the mortality of my body & knowing that it is appointed for all women to die do make & ordain this my last will & testament; that is to say principally & first of all I give & recommend my soul into the hands of almighty God that gave it and my body I recommend to the earth to be buried in a decent Christian burial at the discretion of my executors: nothing doubting but at the general resurrection I shall receive the same again by the mighty power of God. And as touching such worldly Estate where with it had pleased God to bless me in this life I give, demise, & dispose of the same in following manner & form. — First I give & bequeath to Elizabeth Stone & Tabby Biles all my real & personal property what soever them & their heirs for ever after my death to be equally divided between the two sisters at the direction of my executors I do hereby constitute make & ordain & appoint my dear beloved friend James Stone & my dear beloved sister Ann Biles as my executors of this my last will & testament. And I do hereby utterly disallow, revoke & disannul every other former Testaments, wills, legacies, bequest & covenants by me in any wise before named, willed & bequeathed — ratifying & confirming, this & no other to be my last will & test: in witness whereof I have hereunto set my hand

Lastly, I renounce, constitute, & appoint my loving wife Margaret, & my son Matthias Postion to execute this my last will & test. In witness whereof I have hereunto set my hand & seal Janr 13th 1799.

This day declared Peter Shardin & John Goodman, who are duly sworn, concerning the decease of Jacob Beam the 10th of January 1801. Said Shardin & Goodman sat up with the said Jacob Beam all night & about midnight the said Jacob Beam, made this pronouncement that his wife Elizabeth should have the articles in manner & form as follows, that is to say she shall have my house & her bed & spinning wheel & all flax & cotton, & also my daughter Sabanna, shall have her bed & my big bible & the big psalm book, one cow & so much of my household furniture, as she shall have use for, to rings so long as she my live & after her decease, to fore said articles, shall be equally divided amongst my children, viz. my son John, John he is full satisfied, with the plantation. My daughter Magdalena, have to have & cow & heifer & calf & my daughter
