 Burial for the discretion of my Executors hereafter named
 Nothing doubting but to receive the same again at the ge-
 -neral resurrection by the mighty power of God
 And as touching such worldly Estate wherewith it is
 pleased God to bless me with in this life I give
 Divide and dispose of in the following manner
 I give & Bequeath My well and pleasure in that all my
 Just Debts be paid either in right or conscience to any man
 -ner of person or persons whomsoever be first well and
 truly paid by my Executors Hereafter named
 I give & Bequeath to my beloved Son John
 M Henry one Cow within two years my son Henry to buy
 him one house like and my Sister to his Children
 I give & Bequeath to my beloved Son Saml
 M Henry one young mare and if she breeds I permit
 allow him but one at a time and his choice to keep
 the best one or any one of her breed and my Son
 M Henry to keep the best one of her breed and my Son

I give & Bequeath to my Beloved Daughter
 Nancy my Brass Hackle and a Sermon Book.
 I give & bequeath to my Beloved Daughter
 Margaret the price of my Negro Boy Gels and
 him to be valued by two men & that to be paid in ten
 or four years & the Cow she has got to make her a
 Cupboard & my Coarn Hackle & the the common book
 has & all my Coats. I give & Bequeath
 to my Beloved Son Isaac M^r Henry my Negro
 Dutch Sade and the Cow he has got & Grass
 Sermos. I give & Bequeath to my Beloved
 Daughter Jennat my Negro Dutch S. Sue &
 the Horse that goes by her name called shipin
 & her saddle and all the deeper furniture & her bed &
 furniture & my walnut Chest & Cupboard & a large
 Looking Glass and a tea kettle & the Wols and other
 usefuls to be Equally divided between Jennat & Henry
 and my big wheel & spinning wheel & reel & Lard
 Soothing Scons I give & bequeath to my Beloved
 Son Henry M^r Henry my two negro boys Bell & Gels
 my Waggon & Gears & all plantation utensils & grain
 Stone and all Horse Carters that are wanted & walnut
 Table & Stoppin Chest and the Cow Creters and
 all the other thing not Marked in the House
 to be Equally Divided between Jennat & Henry
 Except the Bed & furniture had a long
 time before.

Lastly I name ordain & appoint my Beloved Son
 & Henry M^r Henry my Executors of then my Last will
 & Testament hereby Revoking disannulling all former
 & other Wills Testaments Legacies Bequests & Executors
 by me before this time named Relieving and Con-
 firming then & no other to be my Last will & Testa-
 ment Signed Sealed published pronounced and delivered
 by the S^d Henry M^r Henry as last will & Testa-
 ment in presence
 of us the subscribers
 Witness this Eighteenth
 Day of November one
 Thousand seven hundred
 and ninety two

 memory do this 14th day of August in the year of our
 Lord one thousand seven hundred & ninety two make
