The residue of my estate I give & bequeath to be sold & one third of the money arising from the sale I give & bequeath to my wife the rest I give & bequeath to be equally divided amongst all my children I do likewise appoint my son Joseph Wason & Robert King to be my Executors of this my last will & testament in witness whereof I have hereunto set my hand & seal the day & year above written, Signed sealed & published & declared to be my last will & testament in the presence of us who were present at the signing & sealing thereof.

I George Willcoxon of Rowan County & province of N Carolina being sick & weak in body but of perfect mind & memory thanks be to God calling unto mind the mortality of my body & knowing that it is appointed for all men once to die do make & ordain this my last will & testament, that is to say, first of all I recommend my soul to God that gave it, & my body to the earth to be buried in decent manner, at the direction of my executors & as touching such worldly estate wherewith it had pleased God to bless me in this life. I give demise & dispose of the same in following manner & form.

First I give & bequeath to my eight Children a tract of land lying on Bear creek containing five hundred acres be more or less & that to be equally divided amongst them at the discretion of my Executors.

Also I give to my well beloved children above mentioned, a tract of land lying & being Wilkes county on Roaring River known by the name of the long bottom containing three hundred acres more or less, to be likewise divided at the discretion of my executors

Likewise I give the land & plantation whereon I now live to my well beloved children above mentioned being two hundred & fifty acres to be divided amongst them all at the discretion of my executors.

I also desire that all the rest of my estate should be sold by executors if they see cause to do it, & equally divided

amongst my eight children above mentioned Viz Isabella  
Thomas, David Wilcoxon, George Wilcoxon, John  
Elizabeth, Mary, Isaac & James. I also desire that my  
book accounts should be collected by my execut. and that  
money with what I have in hand & what is due to me by  
notes should be bestowed on my five youngest children  
in schooling & other necessaries one one half Johannes  
& that I give to my beloved brother John Wilcoxon Sen.

I constitute & ordain my beloved son John Wilcoxon  
& David my beloved son the executors of this my last  
will & testament. In witness whereof I have hereunto  
set my hand & seal this twenty first Day of June 1765.

Woods Esq. after getting the mare above mentioned he  
is to have & equal share with the rest of the heirs also  
I do hereby make constitute & ordain Andrew Woods &  
Samuel Woods & John Esq. executors of this my last  
will & testament & I do hereby make void all other wills  
made by me heretofore ratifying & confirming this my  
last will & testament. In witness whereof I have hereunto
