 Swain county and State of North Carolina, planter
 being at this present time much afflicted and dis-
 tempered with bodily paine although of perfect sound
 mind and disposing Memory, yet not knowing
 how soon it may please the Almighty God to call me
 out of this transitory life into some future state
 of exaltance, &c. Therefore Make and Ordain the fol-
 lowing to taken and received as my Last Will & Testament.
 And first of all I recommend my soul into the hands
 of Almighty God the creator and Author of my being
 Humbly hoping that through his great Mercy & goodness
 as also thro' the blood and Merits of his son our Lord
 and saviour Jesus Christ, I shall receive the same
 again in glory at the general Resurrection of all man-
 kind, and as to my body I request, that it may be decently bur-
 ied after the manner and custom hitherto used & observed
 amongst Christian people and according to the discretion
 of my Executor herein after named, and me in this
 will appointed. — As to whatsoever worldly substance
 whether real or personal, which it has been the will of
 God to bless me with in this life, it is my will, Desire
 and request that my Executor dispose of the same in
 the manner following, that is to say all my Just debts
 and funeral charges be by them paid and discharged, but

Item It is my will and request ^{that} the Justice of the worship-
 full court of Swain County do nominate and appoint three
 honest and reputable persons, as soon as the youngest of
 some come to be of Lawfull Age, to value and Appraise
 the tract of land I now live on at ready price, if then
 my said sons being now four, or the survivors of them
 or any them should be willing to retain the said lands to
 himself or themselves at such valuation, such son or
 sons after paying unto their Mother one third part of such
 valuation in such reasonable time as may be agreed upon
 by their said Mother and my Executors herein named,
 and also pay the remainder two thirds into the hands
 of my Executors, and in order to be by them divided be-
 tween each of every of children male & female without
 Distinction or the survivor or survivors of them or any
 of them and such division to be made as soon as circum-
 stances may admit of and in case my said sons should
 not be disposed at the time aforesaid to hold the said
 Lands on the above conditions, it is my will and request
 and I do hereby empower to sell and dispose of the same
 to the best Advantage for the Benefit of my Wife & my
 Children in general, and to appropriate the Money aris-
 ing from the sale of such lands to their Use, That is to
 say one third part to my Wife and the other two thirds to
 be divided by even and equal proportions amongst all my
 children male & female, and it is further my Will &
 I do direct that my Wife Continue to be & the major part
 possession and enjoyment of that plantation & premises

Of every kind the same belonging, for and until my said
youngest son shall arrive to the age aforesaid, without any
set or hindrance whatever
Item I give and bequeath unto my eldest son Jacob Rhodes
ten pounds a piece over and above his share and divided
of my estate — Item I order and direct that the
Remainder of whole Estate, whether improvements pur-
chased or taken up and interest, as also all and every
for my personal Estate of every kind be sold by my exe-
cutors agreeable to the laws of the state and the money
arising from such sale after paying all and every
incident charge, to be divided in manner following
that is to say one third part unto my beloved wife
Mary and the remaining two thirds to be equally
divided between the whole of my children without
distinction as to sex or age, and such divisions to
be paid them who are or may be of proper age,
when such money becomes due and such part or
share as shall happen to fall to those of my young-
est children, I request that the same be put to interest
for their benefit until they receive the same from
the hands of my executor, at their arrival at full age
according to their own — And lastly I nominate,
Ordn, constitute and appoint my Trusty friends Godfrey
Gossett, Philip Woods and My Well Beloved Wife Mary
Executors of this my Will and Testament, that they
confirming this and no other to be my last Will &
