Item I give & bequeath to my grand daughter Polly Green one heifer or cow, which ever my daughter Liviah may think proper to spare after my decease. Item I give & bequeath to my grand daughter Darcus Booth her choice of any cow & calf I possess, after her mother's choice to be hers with their increase together, with my own bed & furniture. Item I give & bequeath to my two great grand children Betsey Green & Rachel Green twenty five shilling a piece to be paid out of the money, that will arise out of the sale of land & other property after the decease of my daughter Liviah before a equal division takes place, amongst my four grand children, as before directed & for the well & true performance of this my last will & test: & for the better carrying the same in effect I do hereby nominate & appoint my daughter Liviah Booth & my well beloved friend Thomas Carson the whole & sole executors of this my last will & test: & I do hereby revoke & disannul all other wills, by me heretofore made & I do ratify & confirm this to be my last will & test. In witness whereof I have hereunto set my hand & seal & pronounce it to

be my last will & test: this 7th Day of July 1798 in the presence of the subscribing witnesses who in my presence subscribed their names as such

I Janet Fritsgare of Rowan County being very sick & weak in body but of perfect mind & memory thanks be given to God - calling to mind the mortality of my body & knowing that it is appointed for all men once to die do make & ordain this my last will & test: that is to say principally & first of all I give & recommend my soul into the hands of God who gave it & my body I recommend to the earth to be buried in a decent manner at the discretion of my executors, nothing doubting but at the general resurrection, I shall receive the same again by the mighty power of God, & as touching such worldly estate, wherewith it had pleased God to bless me in this life I give devise & dispose of the same in the following manner & form.

First I give & bequeath to Elizabeth my dearly beloved wife all my estate both real & personal, whom I likewise constitute make & ordain the sole executrix of this my last will & test: all & singular my lands & tenements by her freely to be possessed & enjoyed & I do hereby utterly disallow, revoke & disannul all & every other wills, ratifying & confirming this & no other to be my last will & test: in witness whereof I have hereunto set my hand & seal 10th of April A.D. 1798.
