West side of Newbury decaying here widow head until my son David Stillwell
comes to the age of Twenty one years then the said David Stillwell is to have the
half of the said Land of Margaret Stillwell should Mary again then the said
David Stillwell is to have all the said Land on the West side of Newbury in his one
possession (and the said Stillwell is to have a young bay mare I do give and
bequeath unto my son Thomas Stillwell all that part of my Long on the East
side of Newbury and one Black mare and all the rest of my moveable Estate to
be repaid to said and after all my debts be paid then the Remainder to be put
out upon Interest until my son David comes of age and the said Land on the
East side of Newbury to be rented out until my son Thomas comes of age and the
Money put out to grace until David comes of age and I desire that no Sheriff, may
nor have any Connection with it but my Executors may have the disposal of it as
there men will and after David comes of age then the Remainder of my Estate to
be equally divided between my wife Elizabeth Gals Mary Jones Jennimah
Jackson Phelo Sister Thomas Stillwell and David Stillwell my wife is
that my wife Margaret Stillwell and John Sedford for be my whole and Sole
Executors and I do acknowledge this to be my last Will and Testament, whereunto I have
set my hand and seal this day and year above written July the Six One
Thousand Seven hundred and Seventy three

that my Executors hereinafter named, Do same time within Twelve Months after my
decease, To sell and dispose at public Vendue all my personal Estate wherever it
may be found, (except one Horse and mare to be and remain the property of my
wife Barbara during her life) together with what else the law may allow her
and the Remainder to be equally divided between my two Sons John and William
is also the sum of Three hundred and Thirty three pounds six shillings and
six pence South Carolina Company that is left to be paid to them

Wife John Ote of South Carolina to be divided between them at my Death, or their coming of age,
and until such time as the do come of age I desire that my said Executors may dispose of such
Money and Estate to the best advantage for them, my two Sons named above, John Will and
demise that if it should please Almighty God to take to himself one or either of them my two
Sons, That then and in that case, This the said deceased his Estate, devolve upon the other who
shall survive, I also Order that in case it please God to take me to himself before my said
two Sons shall come of age, That then it is my pleasure that one of my said two Sons
John Troy be bound as an Apprentice unto Matthew Troy of Salisbury North Carolina until he
shall come to be of age and also that my son John William Troy be bound in like
manner unto Abel Armstrong of the County of Anson until he shall come of age, which
said two persons, Matthew Troy and Abel Armstrong I nominate, constitute and
appoint my sole Executors of this my last Will and Testament, hereby revoking all other
and former Wills by me at any of previous made herebefore. In Witness whereof I have
