James Willson Robert Ramsey my trusty
friends to be my whole and sole Executors of
this my last Will and Testament

Jacob One hundred and fifty Acres of land where
I now dwell to have after my decease, by his pay-
ing there Hundred pounds Current money to have at
eight Shillings to him his Heirs and Assigns for ever

I also give and bequeath unto my Daughter Ruth
Jacobs over and above her equal part of my per-
sonal Estate the feather Bed and furniture that I
lay on her when and Assigns for ever, and as for my
Personal Estate which it has pleased God to bless with
to be equally divided among my children namely
Sarah Gaither Ann Gaither Rachel Gaither Jeremiah Jacobs
Joseph Jacobs Zachariah Jacobs Edward Gaither Jacob
Ruth Jacobs also my house that I hold in Maryland to
be sold by the Executor and equally to be divided among
all my Children above named, and do constitute &
appoint my Son Zachariah Jacobs my whole Sole
Executor of this my last Will and Testament and
do revoke disannul and make void all other Wills by
me hitherto made in witness whereof I have here-
unto set my hand and seal this 10. day of March
Anno Domini 1781. Signed sealed Acknowledged
and declared this to be his last Will and Tes-

day of February One thousand seven hundred Eighty
and three that John Henderson of the State of North
Carolina and County of Howard being sick and
weak in body but of perfect mind and memory
thanks be to God for his mercies calling to mind the
mortality of my body, knowing that it is appoint-
ed for all men once to die I do recommend my
soul into the hands of God who gave it, and my
body to the Earth to be buried in a christian like
and decent manner at the discretion of my Executors
and as touching such temporal Estate as it hath pro-
vided God to bless me with in this life, I do order in the
following manner and form first of all I do order
that all my just debts and funeral charges be paid
and satisfied, ~~And~~ it is my will and I
do order my beloved wife Mary a Horse saddle &
Bridle one feather Bed and it furniture forever
and my plantation and all my moveable Estate
during her widowhood, and keep my family to-
gether untill raised and schooled and of such age
as shall be convenient to be put to trade, and
each one to have the Trade he pleases to choose
