Also to my beloved Son Joseph I give & bequeath the Quantity of two hundred Acres of Land which shall run alongst Postans Line from the River to the Extent of my Land that crosses the bounding lines next to the Tract I bequeath my Son to be parcel to Postans Line. Also to my beloved Son John I give and bequeath a Tract or parcel of Land to the Amount of two hundred and ninety Acres including all the Improvements as also all my Stock including of these viz the Man & three Cows already mentioned and three other Cows which shall be reserved to my Son James if he requires them I do also enjoin my Son John to pay all lawful Demands that shall be brought against my Estate and also to pay the sum of twenty Pounds each to Robert Potter & the like sum to William Potter. I also bequeath my Son James the Quantity of two hundred Acres of Land it being the Remainder of the Tract I at present possess its Boundary and Lines proportional to the other two preceding Tracts. I also bequeath my beloved Daughter <sup>Mary</sup> Martha, the man & three Cows & Calves first mentioned I likewise make constitute & ordain Harry below named Wife Mary now to Executive and John Potter Executor they in conjunction of this my last Will & Testament all and singular my Lands & Messuages & Tenements and I do hereby <sup>with</sup> ~~utterly~~ renounce & throw off & disown all and every other former Testaments Wills Legacies Bequests & Executors by me in any wise made or before named will'd & bequeathed ratifying & confirming this & no other to be my last Will & Testament.
