Item I give, bequeath & demise, to my sons Andrew & Robert  
the land I now live on hereto adjoining to be divided at the  
discretion of my Executors between my said sons ✓

Item I give, demise, & bequeath to my brother James  
all my right the claim, interest & demand for into a certain  
tract of Land, lying on both sides of Elk Shoak creek  
in Judith County, willed by my father to my brother Will-  
deceased, upon condition that my heirs be forever released  
from a certain sum of money which I was bound to pay  
to my said brother James by nature of my father's last will  
Lastly I nominate constitute & appoint my trusty &
