Unto my son Jacob I have already given fifty pounds as his part.

4. I give & bequeath unto my son Adam the sum of fifty pounds as the money now possess, ten shilling to the hard Dollar.

5. I give & bequeath unto each of my daughters Ee Mesomeng children the sum of twenty five pounds.

6. I give & bequeath unto each of my daughters the sum of twenty five pounds good & lawfull money.

7. I give unto John Mesomes five shillings.

If there remains any balance I desire it shall be equal divided amongst my children, & do hereby constitute & appoint my two worthy friends Peter Cable junr & Jacob Fisher, executors of this my last will & test. in Testimony whereof I the said Adam Cable have hereunto set my hand & seal the day & year above written.

4. I will & bequeath unto my sons Wm^r & John Cunningham all my part of the iron works lying in the state of Seneca & Carter County & the land thereto to be equally divided between them.

5. I will & bequeath unto my daughters Elizabeth Dial & Martha Davis the land whereon the said Dial now lives to be divided agreeable to the deed that I have heretofore made to them.

6. I will & bequeath unto my son Joseph Cunningham the land he now lives, on the branch running between his field mine is to be the dividing line.

7. I will & bequeath unto my sons Robert & George Cunningham the two tracts of land lying on the waters of Clinch river in the State of Seneca to be equally divided between them.

8. I will & bequeath unto my daughter Mary Yarbrough

one hundred & fifty acres of land, including the improvement whereon the now live.

9. I will & bequeath unto my daughter Anna One hundred & fifty pounds, to be put out to interest & be given to her as she shall stand in need of at the discretion of my Ex^{rs}.

10. I will & bequeath unto my son Griffith & my daughter Rachel Cunningham, after the decease of my wife Anna all the remaining part of the two tracts of land that I now live on to be equally divided between them.

11. I will that the remaining part of my estate, that I have not already willed, that it be sold & after all my debts are paid the balance to be equally divided between my heirs.

Lastly And I hereby make & ordain my well beloved wife Anna & my son Joseph Cunningham executors of this my last will & test. I witness whereof I the said Joseph Cunningham have to this my last will & test: set my hand & seal the day & year above written.

I give to him & also my lawfull dower of the land whereon I now live also my said dower of two Negro fellows named Samuel & Peter I say him & his heirs forever, & also all the above named children the property which I have named to them & their heirs forever. Lastly I make & ordain my sons John, William & David Cowan joint executors of this my last will & test: In witness whereof I the said Mary Cowan have to this my last will & test: set my hand & seal the day & year above written, Signed, sealed & published in the presence of us.
