 discretion And at my said Wife's decease my Will is that all and singular my
 Goods and Chattels be sold by my Executors hereafter named and the Money
 arising therefrom be divided, and disposed of in the following manner
 Viz To my loving son Samuel Reed one seventh part thereof to him and his
 heirs for ever. To my loving son Andrew Reed one seventh part to him and his
 heirs for ever. To my loving son John Reed one seventh part thereof and to his heirs for ever
 To my loving son George Reed one seventh part thereof and to his heirs for ever
 To my loving Daughter Frances Hall one seventh part thereof and to her heirs for ever
 To my loving Daughter Harriet Anne one seventh part and to her heirs for ever
 To my loving Daughter Mary Willson's two children (to wit) Alexan Willson and
 Margrat Willson the Remainder which is one seventh part. And I will and do
 to my Daughter Margrat Willson the sum of Five Shillings Proclamation Money
 to her and her heirs for ever. Item I give and bequeath to my son Samuel
 my large Bible Lastly I do hereby nominate make Ordain and appoint
 my loving sons Samuel Reed and Andrew Reed Executors of this my last
 Will and Testament, and I do hereby utterly disallow, Revoke and annul
 and every other former Testaments, Will and Legacies Bequests and
 by me in any ways before this time made Willed and Legated, Ratified
 and Confirming this and no other to be my last Will and Testament
 whereof I have hereunto set my hand and affixed my seal the day Month
 and Year above Written

 buried in decent Christian manner at the discretion of my Executors, nothing
 doubting but at the General Resurrection I shall receive the same a gain by the
 mighty power of God and as touching such worldly Estate wherewith it has
 pleased God to bless me in this life I give devise and dispose of the same in
 the following manner and form First I give and bequeath to my dear loving
 Wife Margrat one Twentieth one third part thereof by the name of Rotten's two
 and one tenen Wheel afterwards it is my desire that nothing of my Estate should
 be sold but all my whole Estate to be paid except my Land and my beloved
 Wife to have her thirds of it and the Remainder to be equally divided amongst
 my four Daughters Viz Margueret Mary (Barbony and Moncey) and it is
 my desire that my Wife shall have the two Negroes Tom and Sarah and to
 keep possession of the plantation her life time to raise the children and after
 her decease the Land and two said Negroes to be sold at publick Vendue
 to the highest bidder and the Money to be Equally divided amongst my above
 named Daughters and I do appoint nominate and Ordain my beloved
 Wife Margrat and William Giles my Executors to look after and all my
 Affairs and as nothing of my personally Estate is bequeathed and my Wife
 to keep all in her hands I desire that there will be great care taken for a
 as my children come of age they shall have their full part of my personal
 Estate payed them without any defraud and there part of the Land and
 Negroes after my Wife's decease and I do hereby utterly disal-
 l and annul all and every other former Testaments wills and Legacies and
 Executors by me in any ways before named Willed and Legated, Ratified
 and Confirming this and no other to be my last Will and Testament in the
 whereof I have hereunto set my hand and seal this seventeenth day of July
 in the year of our Lord One Thousand seven hundred and twenty seven
 signed sealed and declared by the said Joseph Goff
