P. Nathaniel Moore of Rowan County & State of NC
Carolina being very sick & weak in body but through the
mercy of God I at this time still retain my right reason
& knowledge of a true direction of my estate, but calling
to remembrance the mortality of my body & being sensible
of the decree of nature & the certainty of death I make
this my last will & testament in the manner following
My eldest son Nathan Moore, in the first place I will
& bequeath him one hundred acres of land with the im-
provement on which he now lives, which I purchased of
Charles Bruce, it being part of my due on a bond which
I have in partnership with one Davis & Barnabas Idol
which we have against him, when my executors shall settle
with the said Charles Bruce, then the remainder of the above
bond shall be his & likewise I do hereby will bequeath & money
to the above Nathan Moore my eldest son a certain power
of attorney which I received & purchased from W^m Paper against
Thomas Seddington.

And to my youngest son Eli Moore I give & bequeath my
homestead plantation on which I now reside, which I purchased
of W^m Paper now deceased, with all my farming utensils
& carpenter tools & a bay mare four years old & two cows
And to my oldest daughter now living I give one brown
horse two years old & one cow & three sheep & further to Mary
Ann my grand daughter daughter of the above Dennis
Credleough I will & bequeath one sheep.

And further I will to my youngest daughter as living
Sarah wife of W^m Credleough one black mare four years
old & one cow

And to my dearly & well beloved wife Cosartner with
me in all my distresses & the only bosom friend attested me
Susanna Jennings my lawfull & spouse wife, I will &
bequeath one Brown mare seven years old two cows &
all the household furniture with the weavers loom &
further this my wife Susanna Moore I order & request
that she shall have a sufficient support for a good
maintenance of my homestead plantation during her widowhood

And further by virtue of this my will & test: I request
& desire of Eli Moore my youngest son to be obliged in
care for his aged mother that she shall lack nothing for a
support during her widowhood under the penalty of breaking
this my will & testament.

And by virtue of this my last will & test: I do hereby
ordain & appoint my eldest son Nathan Moore & Thomas
Credleough my son in law executors of this my last will
& test: & they are hereby directed & authorised & impowered
to settle with my creditors & collect debts due to my estate

& sell the same to the best advantage, & the same hereby required to put the field next to James Pains in good fence & repair the dwelling house & then pay my daughter Damaris ten Dollars & each of my grand children one Dollar & the remainder if any, to be paid to my widow & youngest son Eli Moore after defraying my funeral charges which I require may be decently done. In witness whereof I have set my hand & seal the 19th day of September A.D. 1798.

North Carolina Rowan County the 5th Day of October 1802.
Be it remembered that I Samuel Tomlinson being in a low state of health but of a sound disposing mind. Do make this my last will & testament in manner & form as follows:

First of all it is my will that all my just debts be paid as soon after my decease as they convenient can.
Item I give & bequeath unto my beloved wife Ann Tomlinson full possession of the plantation whereon we now live during her widowhood & that all my stuff be kept together to the best advantage for the raising of my children only it is my will that my executors hereafter named may apportion any of my children at their settling as they may think fit but if my beloved wife should marry that she may be given what the law direct & also direct my executors to make

the best of all my estate both real & personal & divide it as they may think best, only that my lands fall to my son(s)
And I also hereby authorize my executors to make or execute in conjunction with John English a Deed to ascertain tract of land of three hundred acres originally granted to Thomas English in South Carolina, & further direct them to close an agreement between me & Jacob Tacker respecting a small piece of land & if they agree to make him a Deed. And lastly I nominate, constitute & appoint my beloved brothers Will^m Tomlinson, John Riddick & Josiah Tomlinson the whole executors of this my last will & test: hereby making null & void all wills heretofore by me made
