I John Walker of Rowan County being weak in body & knowing that all men must die. Do make & ordain this instrument of writing to be my last will & test in manner & form as followed:

First my will is that all my just debts be paid by my executors here after named.

Secondly For my body to be decently entered by the executors

Thirdly I do give & bequeath to my two sons Moses & John Walker five shillings each they have had their proper part previous to this time,

Fourthly I do give & bequeath to my son William Walker, one hundred & fifty acres of land, lying on the waters of Sura nolle branch of Turkey Creek in Stokes County in the State of South Carolina & further I give to my sd son Will<sup>m</sup> the balance of the bond on James Dott together with a bond on

Garet Smith.

Fifthly I do give & bequeath to my three daughters viz Rebecca - Rachel & Agness one shilling each & after all is settled what ever part of my personal estate is left I give & bequeath to my son William Walker.

And lastly I do constitute & appoint John Haley of Guilford County to be my executor giving him full power & authority to execute this my last will & testament in confirmation where of I have hereunto set my hand & seal this 20. of Novbr 1803.

In the name of God Amen! I Nicolaus Miller of the County of Rowan & State of N<sup>o</sup> Carolina, being in health of body Although ancient & frail & calling to mind the mortality of my body Do make & ordain this my last will & testament. That is to say principally & first of all I give & recommend my soul unto the almighty hands of God who gave it & my body to the earth to be buried in a decent Christian Burial at the discretion of my executors nothing doubting but I shall receive the same again at the general resurrection through the mighty power of God & as touching those worldly estate wherewith it has pleased God to bless me in this life I give deacne & dispose of in mannes & term following.

Item I give & devise unto my son John, that part of my plantation of land whereon I now live & whereon is my dwelling house, Barn, & the greater part of my improvements including by lines running as follows Beginning at a Hickory the Beginning corner of my tract & run thence North, eighty nine degrees east, forty four chains & forty links to a heap of stones a little northward of a Marked Red Oak thence North seven degrees west forty chains to a young Sapling, thence North thirty degrees West one chain & fifty links to a Black Oak Sapling thence South eighty degrees West Crossing a fork of second creek eleven chains & twenty five links to a black Oak Sapling, thence South fifty four degrees & an half West Seven chains & seventy five links, to a stone in the lane thence South eighty degrees West twelve chains & ten links to a Black oak Sapling some small distance from the end of the lane, thence South fifty one degrees & an half West twelve chains to a heap of Stones on the old line thence with the old line South one degree East to the beginning containing by estimation one hundred & forty acres & an half be the same more or less, to have & to hold the above described parcel of land from & after my decease to him his heirs & assigns for ever.

Item I give & dispose twice unto my son Christian All the residue of my tract of land which I have next devised unto my son John, to have & to hold the same

from & after my decease to him his heirs & assigns for ever, agreeable to the old lines & the division lines above described between him & my son John, Also I give & bequeath my Waggon & waggon cover & log chain unto my two sons John & Christian each of them to have a like share therin & I do hereby ratify & confirm unto them all former gifts, And whereas all my other children had each of them received from me the Dowers I allotted them. I give & bequeath to each of them one shilling, or to the heirs of such of them as are dead on shilling & I do hereby ratify & confirm all former gifts. After my decease if any of my goods & cattle remain which I shall not have disposed of the same shall be sold at public sale, & the money arising therefrom together with all other surplusage of rights & credits if any shall remain shall be equally divided among all my children son & daughters sharing alike & the heirs & of such of them as now is or at that time shall be dead, shall inherit a Fathers or a Mothers share as the case may be And I do hereby constitute & appoint my Trusty & well beloved son John Miller & Christian Miller executors of this my last will & test. in whose fidelity I do confide for the faithful execution of this my last will & test: And I do hereby make void revoke & disannul all former wills. Ratifying & pronouncing this & no other to be my last will & test: In witness whereof I have set herunto my hand & seal. 13 January 1807
