moveable effects to be equally shared amongst my wife
my daughters and I hope if it please God to take me
away that Coll John Lopp & Peter Lopp will be kind
enough as to take care of all my beloved children &
see all equally shared amongst them as above men-
tioned. for this my last will I do appoint Coll John
Lopp & Peter Lopp my Executors. And I do hereby
utterly disallow revoke & disannul all & every other
forms, testaments, wills legacies bequests & Executors
by me in any ways before named written & bequeathed
