my last Will and Testament that is to say principally
and first of all I give and be command my soul into
the hands of God that gave it and my Body I com-
mend it to the earth to be buried in a Christian like
manner at the discretion of my Executors by me
hereafter named nothing doubting but at the general
Resurrection I shall receive the same again by the
Almighty power of God and as touching such worldly
estate wherewith it hath pleased God to bless me
with I give devise and dispose of in the following
manner and form that is to say first I give will
and bequeath to my beloved wife Margaret McCarty
the mansion house I now live in during her natural
life and not to be molested by any person
or means and to be maintained sufficiently out
of the Mill and prouvable Estate so that she
be not left to suffer for anything that maybe

I give will and bequeath to my son Lewis McCarty
near the Mill and Cope and worm and what he is
indebted to me I will the payment thereof he
having had his part of Land already Thirdly I
give will and bequeath to my son Thomas McC-
Cartney my home plantation and all the land
I hold on the west side Swearing Creek and on the
East side beginning at a White Oak at the mouth of
a Gut above the Mill running a direct course to a
marked Hickory on the Bank of swearing Creek so as
to include the Mill dam into my son Thomas part
of the old Tract of Land that I bought of Jonathan Hunt
and all my Smith Tools and Carpenter Tools and
four hundred pounds in money to enable him to repair
the Mill fourthly I give will and bequeath to my
Grandson Andrew McCarty all that part of the
(old survey on the East side of swearing Creek eastward
from the line last mentioned including the late survey
Survey and in case he shall die without an heir law
fully beget them it shall return to the heirs of my
two Executors being Males to between them equally
divided and he said Andrew to receive it at the
Years age of Twenty one years and the profits

to the Schooling of him and clothing to the age sixteen
and to be bound to a Trade and to have the of having
Master and Trade with the consent of his guardian
fifthly I give will and bequeath to my Daughter Eliz
abeth M^cCartney one Bay Horse saddle and Bridle
one Sconce and all the Clocking Thence to belonging
One feather Bed and furniture, and one half of my
Personable Estate except such Articles as my Wife
may choose to keep herself for her own use, during
her life then to go to my Daughter Elizabeth and
fifteen pounds hard money to be paid her by my
Executors immediately after my Decease, Sixthly
I give will and bequeath to my Daughter Sarah
M^cCartney one Bay mare saddle and Bridle and
the feather Bed and furniture and half of my Person-
able Estate and Fifteen pounds hard money to be paid
her by my Executors immediately after my Decease
and my two Daughters shall take their choice of each
article and where they cannot agree then the Exec-
utors shall judge between them and they shall take
it at their judgment, and for the more effectual
Carrying this my last Will and Testament into

Execution I do hereby ordain constitute and 89)
appoint my two Sons Lewis and Thomas Executors
of this my last Will and Testament, and I do
order them to find Provinder sufficient to keep their
Cows and Calves out of my home Plantation that
I live on now for the better maintaining my Wife
Yearly and every year during her natural life and
sealed pronounced declared and delivered by the
said Thomas M^cCartney as his last Will and
Testament of him the said Thomas M^cCartney
in the presence of us who were present at the signing
and sealing thereof
