and bequeath unto my son John Call one Cow  
and Calf and unto Henry Call and Adam  
and Daniel and each of my daughters, Margaret

Call, Christiana, Dorothy and Eve, fifteen <sup>(15)</sup> shil-  
lings lawful money of the said Province to be  
raised and layed out of my Estate, next I give  
and bequeath unto my loving Wife Catharine Call  
all the part of the real and personal Estate belonging  
unto me in good lands Chattels during her life  
time and after her decease to descend and belong  
the land unto Daniel Call, and he not choosing  
to take the land it shall be valued by the rest of his  
Brothers and he shall receive and equal share, with  
them Likewise I leave unto my loving Daughter Ann  
Mary Call fifteen shillings, and the rest of my real  
and personal Estate that I leave to my loving  
Wife Catharine Call, I will and bequeath that after her  
decease it may equally be divided all my Children  
And lastly I do ordain constitute and appoint  
my dearly beloved Wife Catharine Call sole executrix  
of this my last will and Testament utterly trusting  
and disavowing all former wills and Testaments by  
me made. Witness this to be my last and  
Witness my hand and seal this 15<sup>th</sup> day of

In the name of God Amen I James Carson  
of the County of Rowan and Province of North Carolina  
being sick in body but of good and sound Memory  
thanks be to Almighty God, Do make ordain and  
appoint this my last Will and Testament and first  
I commit my soul to God my Saviour and  
Redeemer my body to be buried in such a place when  
it shall please my Executors hereafter named, to ap-  
point the expence to be by them paid out of my  
Worldly Substantance and now for the settling of  
my temporal Estate, and such Goods Chattels  
and debts as it has pleased God to bestow upon me  
I do ordain give and dispose of the same in manner  
and form following. First I will that all my law-  
full debts and dues that I owe to any person

or persons whatsoever shall be well and truly  
contented and paid or ordained to be paid within  
convenient time after my decease by my Executors  
hereafter named, and first I allow my family to  
remain together till such time as they think fit to  
part, and to have the benefit of what they can make  
amongst them of the plantation whereon I now live  
I likewise allow my Wagon, Hays and all my  
plantation tools to remain on the plantation for the  
benefit of my family if they see cause to live on  
the land, and that my Wife have the management  
of my Children till such times as they come to years  
of ~~majority~~ discretion and likewise allow my  
Children to be schooled as far as is common, and  
to be paid out of my Estate. I give and bequeath  
unto my Wife Hannah Carson the two Negro men  
named Sprimus and Jack and likewise the wench  
named Sally, together with the sucking Child named  
Abner and her choice of the two best Pigs and Bedding  
that I am now in possession of and likewise to have  
the Dresser and furniture, and a Horse and  
Saddle and her thirds of what is made on the  
Plantation
