

I give & bequeath each of them five shillings, with what they have already had, to be their full share of my estate. In the next place I give & bequeath to my well beloved daughter, namely Barbara, Catharine, Susanna, Elizabeth, Dorothea & Molly. — fifty acres of land, which land is to be sold in one year after my death, & the money to be equally divided among these daughters. I also desire that all my daughters should be at my burring, and the day following the will to be read. & if there should be any money in hand I allow my daughters to receive it & every one to get a equal share.

And I do hereby appoint my trusty friends Peter Hendrix & John Cable executors of this my last will & test: & I do desire that this my last will & test: shall be faithfully fulfilled, & I do moreover, make void, & disallow, all other wills by me made, ratifying & confirming this & no others to be my last will & test: in witness whereof I the said George Patterson sen have to this will & test set my hand & seal this

10th day of November 1803.

In the name of God Amen! I William Cappelius
of the borough of Salisbury, being sensible of the uncertainty
of life, & knowing that it is appointed unto all men once to die
do make & ordain this my last will & test: And first of all
I give & desire all that tract or parcel of land lying on Dyson

Montgomery County, together with all the personal estate thereunto belonging, to my mother for her maintenance during her life & the life of my brother James, then to my nephew Charles Cappelius I give & desire the same to him & his heirs forever — And it is my will & pleasure that my executors hereafter named do make sale of all my possessions wherein I now live, that is the land & premises I purchased of Major Stockes, together with the tract of land I bought of Hull, my stud horse, the young horse called Lamplire, & my library of books this to be done at the discretion of my executors, provided that my wife should not be embarrassed nor interrupted before the gross is secured of the ground. I give & devise to my beloved wife, all my household furniture, two horses a bay & a sorrel, together with all my stock of cattle, likewise all my kitchen furniture. Likewise devise to her former two negroes named Moll & Jupiter also during her natural life I give & devise to her the residue of my negroes viz: Orwell, Teagues, India & Killa: their increase & at her death I give & devise said residue of negroes with their increase, to my nephew Charles Cappelius to him & his heirs forever. It is my will & pleasure that when the surviving partner of Cappelius shall have settled those partnership accounts that the balance of my mother account shall be charged to my estate, I will & desire that my trusty friend Wm L Alexander & Francis Lock should settle my account in the office with Major Stockes, & that their determination on that score shall be a rule to my executors. It is further my will & desire that my funeral should be conducted at the discretion of my wife & that my

family should live together in the situation they now are, support & maintained out of my estate at the discretion of my wife until the time of giving up the possession to my executors to make sale thereof, & as soon as my executors can collect the money arising from the before mentioned sales, it is my desire that, after paying off all my debts against my estate, that the residue thereof should be distributed in the following manner - three fourths thereof paid to my wife & one fourth to my mother & I further will that the tract of land lying on ugly creek Montgomery containing two hundred acres be disposed of at the discretion of my executors to the only use & behoof of my niece Lucy Crawford to her & her heirs forever. And I further will that all the lands that is in copartnership between the honorable John Haywood & myself lying in Montgomery county, likewise all lands in copartnership between myself & Will Johnson & John Wright lying in Anson County be sold by the surviving partner, & converted to the use of George Bradshaw. That is my part thereof - And I further will & bequeath to my wife my double riding chair together with a set of the best harness - my other chair I allow to be sold.

And I do constitute & appoint my trusty friends W^r Allen & George Bradshaw to be sole executors of this my last will & test: revoking & disannulling all other wills etc. by me before made, ratifying & confirming this to be my last will & test: In witness whereof I have hereunto set my hand & seal the 2^d day of March 1800.

We the subscribers, being present at the deathly house of W^r Crawford deceased in his last sickness & the evening before his death (to wit) the 24th day of Feb: A.D: 1807 were particularly called upon & requested to bear witness, that the following, was the nuncupation will of him the said W^r Crawford & the manner in which he desired his property to be disposed of "After his death. viz.

1. It is my will & desire & I do bequeath to my wife Polly Crawford my negro man Dave & his (my s^r's wife) choice of my slaves to her & her heirs forever.
2. It is my will & desire & I do hereby give to my brother John Crawford, all the remainder of my fathers estate, not heretofore paid & delivered me & I do request the executors of said estate to pay & deliver the same to my said brother.
3. My will & desire is, that my father in law Martin Phifer have the sole & entire direction & ownership of the remainder of my estate, to be managed, conducted & disposed of in such manner as he the said Martin may think proper.
4. It is my will & desire, that my friends John George Phifer & Robert Locke, shall have the care & direction of the education of my son W^r Crawford.

In witness whereof we have caused the said nuncupation will to be reduced to writing & signed by us this 6th day of May A.D 1807.
