9. I give and bequeath unto Christian Everhard my Gold Medals.

10. I give and bequeath unto Susannah Stoy my Knitting Spoon

11. I give and bequeath unto Heinrich Stoll my large silver Snuffbox.

12. I give and bequeath unto Dorothea Byhon my Bed Furniture

13. I give and bequeath unto the sister who attended me in my sickness the sum of Ten Dollars.

14. I give and bequeath unto Samuel Stoy one Hundred Dollars

15. If after the sale of my Furniture Bedding Clothing &c. that has not been utilized before and after the payment of my funeral expenses and other charges, any thing should be left it shall be divided among the poor especially the widows in Salem. at the option of my executor not to forget Mary Samuel near Bethabara

16. I constitute and appoint Samuel Stoy of Salem executor of this my last will & testament and it is my request that he act agreeable to the foregoing Hint at thereof
