be interred in decent & Christian manner. & touching my
earthly estate wherewith it has pleased God to bless me, I
desire toqueather the same in following manner

1) Give £5. per month unto my beloved Christian Friends Pfoll in Beth-
ania for the bearing of his children, attorney fees, clothing, inn, board, my
bed & what.

2) Give & bequeath unto Samson Thomas Henge in Salem my Dauchile
the sum of thirty dollars in her may day watch one large & small upon
one pair of silver knee buckles.

3) Give & bequeath unto the other five children of said Christian Thom-
as Henge of Bethania, that is to say, to his son Thaddeus Christian,
of de Grahams Benjamin Pfoll & his daughter Dorothy Elizabeth
Pfoll Charlotte Innes & Caroline Elizabeth Pfoll, each of
them the sum of five dollars in hand money, that is to say in all
twenty five dollars.

4) Give & bequeath unto my Dauchile Daugott Hengs
of Salem the sum of fifteen dollars hand money.

5) Give & bequeath unto the Society of the United Brethren
for the furtherance of the Gospel among Brethren in Bethania
the sum of ten dollars in hand money.

6) And give & bequeath unto Lazarus Elizabeth Gots of Salem
the sum of twelve dollars in hand money.

7) And leave & appoint my wife from a & the house
in which she shall after me die my just debts & the house
in which she has been placed over day & night of money remain-
ing in her hand shall be divided among the house mentioned above
in equal share & in case there should be a difference of con-
cerned

8) And leave & appoint my master friend Leonard Gots
of Salem to be my executor of this my last will & testament
unto my wife from a & the house mentioned above
