

27) In the name of God Amen
I Gottlieb Shober being old and out of sound mind depy witness
to make this my last will and Testament in manner and form
following (My dear wife having died a few days ago.)
I) My Lot of Ground in Salem including my dwelling House Book Store
with the Post office and other improvements with an out Lot and
improvements shall be sold by private sale; and if any of my
children or a grand child is the purchaser, for the purpose of
inhabiting the same legally he or she shall have the same for
two thirds of its reasonable appraised value for ever according
to the Salem Taxes; And the proceeds of the sale shall belong to the
rest and residue of my Estate, as also the two thirds of paid
by any child or grand child of mine as above said.

II) My private Library shall only be sold in the family and to be
divided that each child then alive at the sale shall receive
equal in value and the children of my deceased children shall
have their share of them parents as if they were alive
and absent children or grand children may appoint an Agent
at the distribution of the purchase made or leave the distribution
to my executors

III) My daughter Sertwin Elizabeth is hereby requested to give
to my Daughters Paulina and Teresa from my Trinkets often
used and pictures as much as will please them or their children
without accounting the value

IV) The rest of my Pictures Prints China ware and whatsoever
Belong and Emanuel do not retain for themselves and which
is in my dwelling House in Salem such as painted Pictures,
they may distribute them as they please among them selves or
others or relations

V) I give to my Daughter Sertwin Elizabeth four thousand Dollars
and Enock my Servant until he can be legally liberated
I also give to her my Gold Watch

VI) I give to my son Emanuel his Bond to me for three thousand
Dollars which is in part of his legacy and is therefore deducted
And I also give to him my Negro Woman Nancy
best of the and Enock her husband can be legally liberated
and they promise to move to Liberia in Africa They shall
be free but not before they have moved and my Executress
may pay the ship freight out of the residue of my estate

VII) I give to the widow of my deceased son Nathaniel Rebecca
One hundred Dollars to Rosina Blodner One hundred Dollars
& to Elizabeth Simbeck for her own use one hundred
Dollars

28) I give to every Sunday School in Existence at my
decease and any such as hereunto with the American Sunday
School that the Stokes County Union Ten Dollars each for
increasing their reading Libraries and the Ten Dollars for each
is to be placed in the Stokes County Sunday School Union
in Sunday School Books or money in tracts for the above purpose

IX) All my Land in Surry and Stokes County I desire in full
simple to my Son Emanuel on conditions that he pay for
the same at the rate of five Dollars per hundred thousand
charge no expenses and account for it in the division of
the rest and residue of my Estate And if he does not
choose to own it at that rate or price I desire all said
Land to be sold by private or publick sale in a lump
or in parcels by my Executor or either of them with power
to convey by themselves or their Agents or agents to the
purchaser by Special Warranty

X) The money on hand the outstanding debts goods and Books
on hand in the Store or Loft is the foundation of all
specific legacies hereinbefore mentioned and bequeathed
and my Executors are requested to deliver all specific legacies
in 5 months or less and the money legacies in six months
or to secure to the legatees Interest at the rate of five
per cent at least from four months after my decease until
the possessor can come in and be paid to them

XI) All the rest and residue of my Estate both real and
personal not hereinbefore particularly devised shall be
sold or rented or hired out to the best advantage by my executors or
either of them or the survivor of them by private or publick
contract or sale at their or his option and they may hire a
clerk or Store Keeper and pay him out of the Estate with
power singly or jointly to endorse creditors notes without recourse
or make Special Warranty Deeds on all sales of land

and the proceeds of the whole and which is not wanted to pay debts funeral
expenses and the above legacies shall be equally divided in 6 shares
to be divided among my children or their representatives as soon as may
as one hundred dollars and 40 Dollars are required out Emanuel Shober
Paulina German Teresa Weller Sertwin Eli Shober and the children
of Johanna Givley and the children of my son Nathaniel or
their heirs

6 Shares all alike and the acting Executor
or administrator may retain reasonable for cost from each
share for their trouble besides all necessary expenses.

XII) If at any time any thing should be obtained procured
and recovered on my purchase of land in Mary land from
the Nantucket Indians as recorded in Surry County

29) These or former partitions or their heirs of my land & plantation
in the year 1795 & all belongs to my son Emanuel & obtained at
his private expense.

XIII Should any differences arise between the Legatees and Executors
My will is that such shall be settled by sensible Arbitrators impartially
chosen by both parties from citizens of Salem who of they cannot agree
may choose an umpire whose decision shall be final

XIV And I do appoint my son Emanuel and Christian Blum
Esq: or either of them or the survivor of them Executors of this my
last will and Testament trusting that he or they or an Administrator
appointed by the court in case of Death or resignation will act
themselves with such perfection as humanity allows, an honor
and I do hereby revoke all former will or wills by me ever made
proclaiming in the presence of the abiding witnesses hereunto annexed
that this and no other is my last will and Testament

Codicil to my last will and Testament which was executed indented
on the 19 Day of June 1835 As it was always my will to assist in
extending the Kingdom of our Lord Jesus Christ by pure doctrine
without enthusiasm and believing that the desire to extend pure heartfelt
religion among so called Christians is a thing of the highest necessity
to prepare souls for the meeting of the Saviour either by being called
home or at the appearance of the Judge among us
I think it to be of the utmost consequence to appoint and send out fully
authorized preachers of the gospel according to the Augsburg Confession
and Luther's small Catechism or the doctrinal theorum contained

30) Which is also the desire of the so called Moravian
Brotherhood or Moravians to visit families hold meetings with them and
their children in order to encourage them not to offend upon
the test to which they may belong but only on slips of giving down
I therefore believe that a Society ought to be formed to propagate the
pure Doctrine of Jesus as he preached them and a preacher by them
sent ought to be independent of European dictation but only to send
rules as the Bible & New Testament contains from which rules for
the Society and the preacher to be sent ought to be formed according
to American principles without despotism and only kindly dictation
such as the Society of Friends Christian approves off

Now as the Moravian Brotherhood have formerly done much in this
line with evident blessing to immortal souls and for bringing also
children to the Lord I think they ought to renew their exertions
and so as to erect private schools similar to be attended by a
Moravian fully authorized Minister who also in case of opportunity
is openly to preach & administer the sacraments to such whom
they approve of as believing disciples of Jesus

If then such a thing is to be done it requires many
start if the Directory of the North Carolina Moravian Ministry
do erect such a Society for the above Gospel & for sending by that
Society the above Standard Gospel, which I have by my
will authorized my executors to pay to such Society twenty five
dollars a year for 5 years to come. This is one hundred dollars a
Year. as a beginning of a society fund But if no
such Society is erected for such a purpose nothing shall
be paid by my Executors such a minister will no doubt
receive instructions to report monthly to a board appointed
by the Society off his labors & prospects

In Wethersfield Whence I have to this codicil of my last will
