I Isaac Barr of Stokes County & State of North Carolina being weak of body, but of sound mind & memory (thanks be to God for his mercy) do this 10th day of November in the year of our Lord one thousand eight hundred & thirty two make & ordain this my last will & testament in manner & form following (to wit)

In the first place at my decease I recommend my soul to God who gave it & my body to the earth to be buried in a decent manner And as touching such worldly property as it may & has pleased God to bless me with, It is my will that it be disposed of as follow(s)

I having been a revolutionary soldier am now receiving a pension from the United States for my services in said war & for the natural love & affection which I have for my beloved daughter Elizabeth she having been attentive to me in my declining age & infirmity & also during my present prolonged illness. I give & bequeath to my said daughter such sum of money as may be due & owing to me from the United States at my decease & also I give & bequeath to my said daughter Elizabeth all the residue of my estate both real & personal that I may die possessed of except the bequests hereinafter made. I being possessed of but little worldly property & the rest of my children all having left me, in remembrance of them I give & bequeath to them as follows (to wit) to William Barr, to Nancy Gregory to John Barr to Polly Owen to Isaac Barr to Sally Coomer & to Joshua Barr twenty five cents each.

And I do hereby make ordain & appoint my beloved daughter Elizabeth Barr Executrix of this my last will & testament. In witness whereof I do hereto set my hand & seal the day & year above written

I Rice Brown a citizen of Stokes County & Carolina being now in health but enjoying sound sense & good reason do make ordain & declare this instrument to be my last will & testament.

I first all my debts to be ~~promptly~~ & punctually paid, then the residue divided as follows. To my beloved wife Nancy Brown I give & bequeath the third part of my land on which I now live including my dwelling house with sufficient quantity of lumber & fire wood to keep up the same during her natural life together with my household & kitchen furniture to be hers to dispose of according to her own will & direction & one cow & calf with some plantation tools as her own.

To my son George Brown I give & bequeath the one half of the remainder of my land & of my wifes dower of land at her decease.

To my daughter Nancy Brown I give & bequeath the other half of my land & the other half of my wifes dower of land at her decease together with one cow & calf & my mare. The remainder of my cattle & as cow here to be sold to defray my debts & other necessary expenses plus of such sale I give & bequeath to Elizabeth Hutton, & to my daughter Polly Hutton I give & bequeath my household & furniture.

My stock of hogs I give & bequeath to the use of my beloved wife & family. The foregoing I do hereby declare to be my will & testament this 11th day of June in the year of our Lord 1832.
