

In the name of God Amen!

Jacob Pitoy of Stokes County in the State of North Carolina Farmer being in good health & of sound mind and memory thanks be given to almighty God, calling into mind the mortality of men & knowing it to be the destination for all men one to die Do make & ordain this my last will & testament viz. Principally and first of all I recommend my soul into the hands of my Creator Jesus Christ & my body to be buried in Decent Christian Burial at the discretion of my executors, and as touching such worldly estate wherewith it hath pleased almighty god to bless me in this world, I give and demise the same in manner & form following viz.

1st whereas I have heretofore made over and delivered unto my two sons named Henry Pitoy & Jacob Pitoy all my tract of land with my plantation & improvement thereon situate lying and being in Stokes County on both sides of the western Creek as by the several instruments of writing or namely Henry Pitoy's bearing date the 20th of May 1795. & Jacob Pitoy's bearing date the 26th of February in the year of our Lord 1798. more fully and at large appears. Now it is my will that immediately after my decease, my executors hereafter named shall make out unto my two

sons named my sons Henry & Jacob a good and lawful Deed of Conveyance in full sample for the aforesaid stated land to have and to hold the same for themselves and their heirs forever, reference must allways be had to the aforesaid instruments of writing to all intents and purposes.

- 2.) All the remaining part of my estate shall after my Death be divided as follows viz. I give to Eva Barbara my Daughter married to Adam Wolf viz: one Dollar of the United States and no more, the rest of my Children shall have an equal share they are named John Henry Jacob, Adam, John, Mary Catharina Mary Dorothy Elizabeth Margaritha and Johanna each and every one shall have an equal share out of my estate
3. And whereas two of my aforesaid sons named Adam & John are already dead, I will that the share of my estate which I have hereby given and demised unto them shall be given to their Children to be divided between them share & share alike. namely Adam's share shall be equally divided into six parts amongst his six children named Sarah Barbara, Elizabeth, Mary, Catharina & Francis and likewise John's share shall be equally divided into seven parts amongst his seven children named Susanna, Jacob, William Mary, John, Henry & George and this their share they shall have and hold for themselves & their heirs forever
- 4.) And I do hereby make ordain constitute & appoint my trusty Friends John Kraus & my sons Henry Pitoy & Jacob Pitoy Executors of this my last will & testament who are hereby empowered to pay off all my Lawful Debts & settle all my accounts and I do hereby discharge

55 & make void all my former wills or legacies
done by me either in writing or by word of
mouth ratifying & confirming this & no other to
be my last Will and Testament

during her life

Item. I give and bequeath unto my beloved son Jeremiah
Beasley all my land where I now live and all Plantation
Utensils and Stock of horses cattle hogs Sheep and all
my household goods of all kinds and all Tools and
all my whole estate only what is hereafter excepted
to my other children that I have partitioned of before
and further my will is that my wife & son Jeremiah
would not divide the estate but keep it together as
they might think proper.
