I James Matthews of the County of Stokes in the State of North Carolina being such & weak in body but of perfect sound mind & memory for which I thank God and call upon him my human Gratitude and that is appointed for all men once to die do make and ad in this to be my last will & Testament that is to say first of all I give my soul unto the hand of Almighty God nothing Doubting but that at the general resurrection I shall never be same again by his mighty power and my body to the Earth to be buried with Christian burying by my executors and as to what worldly estate it hath pleased God to bestow on me in this life I give & bequeath in manner & form following first I give and bequeath unto my son Sandy Matthews my home tract of land where I now live on Townfork County State of Virginia containing two hundred & forty acres eight acres together with six hundred acres of the land which I purchased of Charles Beazley to begin at the west end of said tract and one hundred acres of land on Blues Creek late the property of John Thompson also nine hundred & odd acres of land in the hands of John Griffith in the State of Virginia together with one Negro fellow named Dick and Annaky his wife & their increase after my decease also a negro boy named Steffey now of the age of four years I also give and bequeath to Joseph Hollenworth in trust for his son James Hollenworth six hundred acres of the land I purchased of Charles Beazley to include the Mansion house known by the name of the New Chimneys Also on negro Wench named Fena their increase also one negro wench named Silla unto Aquilla Hollenworth daughter of Joseph & Mary Hollenworth Also I give & bequeath a negro arnch named Rachle to their son Sandy Hollenworth their increase & his mother Mary Hollenworth to have the use of said Wench until her son Sandy comes of age, should he die in infancy the said negro to be sold the price divided amongst his surviving brothers & sisters — Also I give & bequeath to my daughter Betsy James one negro girl named Anne in trust for her oldest daughter & should her oldest daughter die in infancy the march then increase to be sold & the price to be divided amongst all her surviving children Also to my daughter Betsy one negro girl by name Nelly in trust

for her children but she her self to have the use of said wench & her increase during her life and at her death to be sold and the amount in money of said sale to be divided amongst all her children Also I give & bequeath unto my son Sandy Matthews in trust for all my daughter Betsy's Children nine hundred acres of land known by the name of the Walord corn in the lower end of Pounds Valley to be sold to the best advantage — Also I give & bequeath unto Joseph Hollenworth in trust for the Children of my son William Matthews Six hundred acres of land being the balance of the tract I purchased of Charles Beazley to be laid off on the East end of the said tract to be divided as the Children & am agreed should they not agree to be sold and the purchase money to be equally divided amongst them all and I will that Dole the increase go to the Children of my said son William Matthews as also a wench he has in his possession by the name of Jenny — also I will & bequeath to my son Sandy for trust for any the Children of my son John Matthews & Polly Martin his wife Day James Tracy to James two hundred acres of land on Panther Creek in Stokes County and to Nancy two hundred acres of land in Amherst at the East end of the great pier View, State of Virginia, all the education what ever of the said two Children to be at my expence exclusive of the above legacy Also I give & bequeath to my son John Matthews Four hundred acres of land lying on the Waters of the little Yadkin — Also I give and bequeath unto Obidiah Braumum two hundred & thirty five and $\frac{1}{2}$ acres known by the name of Blackburn with a good horse bridle & bit to receive a liberal education at the expence of my estate Also I give & bequeath unto Irvin Braumum three hundred acres of land late the property of James Coffey and a horse Saddle & bridle & to be liberally educated at the expence of my estate — Further I will to my son Sandy a negro man named Frank also I will a negro girl ~~named~~ by the name of Agnes to my daughter Betsy & her Children forever Also I give & bequeath unto Obidiah Braumum & Ervin Braumum a girl by the name of Courtney in the possession of Anna Braumum with her increase for the use of her Children — I will a negro boy by the name of Stephen to James Matthews son of Sandy Matthews.
