3rd. I give and bequeath unto my daughter
Milley Nokes one Shilling Sterling money.

4th. I will and bequeath unto my wife Elizabeth
& oney my daughter and my daughter Elizabeth
all of my Estate not yet bequeathed to be equally
divided among the three. I wish my wife one
Third, my daughter Oney one Third & my daughter
one Third.

And I do hereby make and ordain
my wife Elizabeth Dawson executor of my
last will and testament. And I do hereby
wholly revoke and renounce and make void
all former wills & testament by me at any time
hitherto made ratifying establishing and
confirming this & the other to be my last will and
testament. In Witness whereof I the said John

four acres to him and his heirs forever reserving to my
beloved wife Mary the house and plantation until my son
shall arrive to the age of Twenty one years. or during her
widowhood only.

It is also my will and desire that my beloved wife
Mary be in possession of all my household goods and
farming utensils as long as she shall remain my
widow but at the decease of my wife or expiration of
her widowhood the whole of my moveable property
be equally divided between my three daughters namely
Elizabeth Gray & Mary.

And lastly I make ordain constitute and
appoint my Trusty friend Jonathan Mundingwell

and my beloved wife may joint executors to this
my will. hereby ratifying and confirming this &
no other to be my last will and testament
in manner and form aforesaid. In testimony
