I Juliana Hise in the County of Stokes State of North Carolina being in a declining state of body but of sound mind & memory blessed be God for the same & all his other mercies & favours conferred on me and calling to mind the uncertainty of this mortal life I have thought fit to make this my last Will & Testament —

First of all I give and recommend my soul in the hand of Almighty God that gave it & my body I recommend to earth to be buried in a decent Christian burial, at the discretion of my Executors nothing deterring but at the General resurrection I shall receive the same again by the mighty power of God —

And touching such worldly estate wherewith it has pleased God to bless me in this life I give & dispose of the same in the following manner and form (vizt)

I give and bequeath to John Peter Hise the son of my late brother Peter and to Samuel Benjamin Hise the son of my brother Henry my piece of land containing 20000 more & more alike but if the former should die his share shall fall to the latter. The condition is such that the land shall be sold & the money put out upon interest without delay if both should die the whole shall fall to my brother Henry And I give and bequeath to my daughter Juliana both — Anna Hise my flax wheel 2 counterpane & sheet 1 green frock one black silk handkerchief all my flax & the value of my saddle which shall be sold And I give & bequeath to my brother

Henry Hise my share of my father's land situated in the Freedland settlement Likewise after my mother's decease my share of the price of land from my father's estate — Likewise such sum of money as he (said Henry) shall owe me for a cow sold him in the condition that he pay out of it all my remaining debts —

And I give and bequeath to my sister Christina Schultz 1 shawl & 1 white checked counterpane

And I give & bequeath to my sister Catharina 1 bedstead 1 shawl & 1 white petticoat

And I give and bequeath to my sister Mary Hise 1 quilt 1 light

calico frock 1 white checked handkerchief and 1 sheet And I give and bequeath to my sister Susan Rector 1 cotton wheel 1 light calico frock & 1 dark coloured shawl —

And I give & bequeath to Mary Hise the wife of my Brother Henry 1 featherbed 3 pillows 1 sheet 1 dark flowered & 1 dark calico frock 1 white shawl & 1 green silk bonnet

And I give & bequeath to John Hise 1 sheet (blank)

And I give & bequeath to Maria Rebecca Holder my sister Mary's child 1 white frock And I give and bequeath to Louise Hauer (Lange daughter) 1 white flowered cape & 1 shawl & 1 sheet

And I do hereby constitute nominate and appoint my trusty friend John Hise of Bechtelara Stokes County North Carolina to be executor of this my last Will & Testament

And I do declare this to be my last Will and Testament hereby revoking all former wills by me heretofore made

In witness whereof I have hereunto set my hand and seal the seventh day of December in the year of our Lord one thousand eight hundred and twenty
