I Give unto my Daughter Rebecca Spambach two hundred and fifty acres of Land it being the tract that was commonly called High Clover old place for which she is or shall be charged out of my Estate two hundred dollars.

6th I Give unto my Niece Susana Grandfield my Daughter Frankys Daughter one hundred acres of Land more or less adjoining David Spambach on the west side and Frederick Woffles Land on the East side and also my small diormer cupboard and my Loom and all thereon to belonging that is to say harness and Rags &c and I give unto sd Susana out of my Daughter Frankys part fifty dollars to deducted out of his part and by my Executors given to Susana my grant Daughter also I give unto my grant child Susana after my dees all my hand money

7th after my Decease all the remaining part of my property m^{ch} herein mentioned shall be disposed of at publick sale by my Executors and all debts due and demands due me by Book account or other wise shall be collected by my Executors and be cleared among my heirs in Equal share a like except my Daughter Franky Borath who is to have fifty dollars deducted out of the amount of her share and given to her daughter Susana as if herein forementioned in consequence of money advanced her that came by Susanas father other wise to share in amount equal and alike with all the rest of my children

And Lastly I nominate ^{consistors} and appoint my two sons Joseph Spambach and Solomon Spambach Executors of this my Last will and testament and Revoking all others declared Me and Me alone to be my Last will and Testament In Witness whereof I the said John Jacob Spambach have to this my last will and testament set my hand and seal this twenty fifth day of July AD 1821
