My clothing shall be divided among my four daughters or the survivor of them — I wish to be buried at the burying ground where my first husband Leonard Moser is buried. & I give six dollars to my executor for the purpose of procuring tomb stone for him & myself.

My household furniture shall be sold by public sale and the proceeds therefrom and all my personal estate shall be equally divided among my children, Sarah, Noah, Peter, John, Francis, Moser, Christian Moser, Henry Moser, Michael Moser, John Moser, Ann Mary Wolff, Elizabeth Hef & Christina Eizen first deducting the above six dollars & burying as aforesaid —

And I do appoint Henry Moser & Peter Moser executors of this my last will & testament I writing whereof I have hereunto set my hand & seal the 10th day of February 1815

I Richard Clamphitt of the County of Stokes & State of North Carolina being of sound & perfect mind and memory (blessed be God) do this third day of eleventh month in the year of our Lord one thousand eight hundred and nineteen make and publish this my last will & Testament in Manner following, that is to say —

First I give & bequeath to my beloved wife my pecuniations & all and every of the appertinances belonging therunto during her widowhood but if she should marry then my pecuniations & the appertinances belonging therunto shall be equally divided between my two sons John & Ezekiel Clamphitt and the profits arising from the same — I will that my wife possess during her widowhood (2^d) I give & bequeath to my son George Clamphitt one dollar (3^d) I give & bequeath to my son Wm. Clamphitt one dollar

(4th) I give & bequeath to my daughter Dinah Beeson one dollar (5th) I give & bequeath to my son Mathias Clamphitt one dollar (6th) I will that my son Rich^d Clamphitt have one horse out of my estate

(7th) I give & bequeath to my daughter Elizabeth Hef one dollar (8th) I will that all my movable estate shall belong to my beloved wife Elizabeth during her widowhood but if she should marry then

the same shall be equally divided between my two sons John & Ezekiel Clamphitt & I hereby make and ordain my worthy friends my wife Elizabeth & my son John Clamphitt executors of this my last will & testament I writing whereof I the said Richard Clamphitt have to this my last will & Testament set my hand & seal the day & year above written
