- 4d to my Brother John forty Dollars
- 5d to my Brother Benjamin ten Dollars males in the land situated in Orange County North Carolina
- 6d to my sister Catharina ten Dollars
- 7d to my friend Moriah Elizabeth wife of Christ... ten Dollars
- 8d to my niece Amy wife of Joshua Reight ten Dollars
- 9d to my friend Polly Magaman ten Dollars
- 10d to my friend Shopsy wife of Emmanuel Reuch ten Dollars

12d to my friend Barbara Shuttle five Dollars
 14d to my little friend Ema daughter of Phillip & Sybilla Reuch one bed bedstead & furniture his bed & at present in the care of Moriah Tupper widow

15 all the rest & remainder of my estate namely house & kitchen furniture cloths Carpets bed & of whatsoever named & Description I give & bequeath to my nieces Louise & Amette & Sybilla wife of Phillip Reuch to be divided amongst them equally & in case that my niece Catharina wife of David Glueck should have returned at or before my funeral to have an share also but in case she has not returned at the above mentioned time then my niece herein named may give to her whatever they may think proper

16d I do hereby appoint my friend Edith Reuch of Salem Executor of this my last will & testament
