I William Barton Paddycoast of the County of Stokes North Carolina Planter being weak in body but of perfect mind & memory Thanks be given unto God calling unto mind the mortality of my body & knowing that I am appointed for all men once to die do make and ordain this my last will & Testament that is to say Principally I give of all I give & recommend my soul into the hands of almighty God that gave it, and my body I recommend to the earth to be buried in decent Christian burial at the discretion of my executors And as touching such worldly estate wherewith it hath pleased God to bless me in this life it is my will that all what is left at my decease is to be sold as a public sale and the money afterwards equally divided among the following of my Children viz Granbury, Thomas, William, Horatio, Sarah and Lucy

My daughter Mila and Elizabeth who formerly have received Negroes and other things are to receive five shillings each. which money as well as all my lawful debts are deducted from the above before it is divided.

Lastly I appoint my brother John Paddycoast and my son Granbury Paddycoast to be Executors of this my last will & Testament

I Just Kapp of the County of Stokes in the State
of North Carolina being weak in body but of sound
perfect mind & memory do make & publish this my
last will & Testament in manner & form following
First I will that all my just debts be paid by my
Executors —
Secondly. I give unto my beloved wife Louisa
Two four my house flock & all her & his furniture
Thirdly It is my will that my land & plantation

containing one hundred acres shall by my executors
or either of them be sold out & the moneys so bargained
for shall be & come to the sole use & benefit of my
said beloved wife Louisa during her widowhood
and at the determination of her widowhood or when
the said one hundred acres shall be sold by my
executors or either of them or the survivor of them
by public or private sale & they or either of them shall
be competent to make a lawful conveyance for the
same. The money arising on such sale shall be
divided into two equal parts if my said wife Louisa
is alive & she and my first Children Frederick, Ann Mary,
Henry, Jacob and Louisa shall have each one share
so that they all have share & than alike but if my
said wife is dead when the land is sold the proceeds
of such sale shall be equally divided among my
above named Children share and share alike

All the rest & residue of my estate real &
personal not herein before specially bequeathed I
desire to be sold by my executors or either of them by
public or private sale and on receipt of the money
on the sale arising my said executors shall divide
the same equally & pay the same in equal portions
share and share alike to my said wife Louisa & my
Children Frederick, Ann Mary, Henry, Jacob & Louisa.

And I do hereby appoint my Trusty friends
Gottlieb Packer and Gottlieb Fockell or either of them
Executors of this my last will & Testament

And lastly I do appoint my Trusty Friend
Abraham Hinner Guardian of my Children
during their Minority — Hereby revoking and
