The Last Will and Testament of Rubens Shields

I Rubens Shields Considering the uncertainty of the
 Mortal life and being of sound mind and memory blessed be the
 Almighty God for the same do make and Publish this my last Will
 and Testament in Manner and form following to w^t
 First I give and bequeath unto my Beloved wife Elizabeth Shields

My house and a sufficient support and Maintenance of the
 Plantation during her Life or widowhood and after her decent support
 is made out the Balance of grain and other produce raised to
 belong to my Grandson Elisha Shields who now lives with me
 and tends the Farm provided said Elisha Shields continues
 to tend and cultivate said farm

Secondly I will that my wife Elizabeth have my Gray Mare also
 I will that my wife Elizabeth have one Cow and to have her Choice
 also I will that my wife Elizabeth have one feather Bed and have her
 Choice with its necessary furniture

Thirdly I will that my wife Elizabeth have one half of all the
 Bedding of Household and Kitchen Furniture

Fourth I will that all the before mentioned articles that I
 bequeath to my Beloved wife Elizabeth accept the same that she
 will and dispose of said property as she thinks proper.

Fifth I will that my Grandson Elisha Shields have all my lands
 and premises in fee clear of all Incumbrances whatsoever
 at the death or marriage of my beloved wife

Sixth I will that if the said Elisha Shields should die without leaving
 me my Grandson Andrew Shields heir the same lands in fee

Seventh I will that my son Abel Shields have one dollar of my estate and none

Eighth I will that my son Samuel Shields have one dollar of my Estate and no more

Ninth I will that my daughter Lydia wife of Jacob Beacon
 have one dollar of my Estate and no more

Tenth I will that the balance of my personal property be
 sold after my death and equally divided between
 the rest of my heirs that is to say William Shields

 Payne and my Grand Daughter Mary Idol
 Eleventh I will that my Grandson Elisha Shields have one half
 the income of the Gray Mare
 Thirteenth I nominate Orsam and appoint Daniels Hendricks sole
 Executor of this my last will and Testament

 October in the year of our Lord Eighteen Hundred and Thirty seven
 make and publish this my last will and Testament in manner following

That is to say

First I give and bequeath unto my dearly beloved wife Margaret Springer
 all my land with the exception of my Sawmill and such privileges
 as is necessary thereunto and at certain Negro boy named Adam to have
 while she remains to be my Widow and also fifty Dollars in cash to
 buy her A House to have forever and one years provision

My Sawmill I wish rented out for Ten years and the proceeds to
 be applied to the education of my two sons Joseph and William
 after this I wish all my property both personal and real to be
 equally divided after all just debts are paid between my

Children and wife. That is to say my Dearey beloved wife

Margaret Springer my Daug her Christina Springer Lamb Springer
 and Philia Jane Springer and my sons Joseph & Springer

and William J Springer and I hereby make and appoint my
 friend Jacob Ferguson and my beloved wife Margaret Springer
 Executor & Executrix of this my last will and Testament in writing
 where of I the said Wm Springer have set my hand and seal
 the day and year above written
