last will and Testament that is to say Principally and first of
all I Give and Recommend my Soul unto the hands of Almighty
God that gave it and My Body I Recommend to the Earth
to be Buried in Decent Christian burial. At the Resurrection
of my Exer? Nothing Doubting but at the General Resurrec-
tion I will Receive the Same again by the mighty Power
of God and as touching such Worldly Estate where with
it has pleased God to bless me in this life I Give demise
and Dispose of the Same in the following manner and form
(Viz) First I Give to Sibbela my dearly beloved wife that
part of my Plantation that I now live on lying on the South
Side of Dan River with all the Improvements thereon by her
freely to be Possessed and Enjoyed during her life time And
at the Expiration of her life I Give the Same part of my Planta-
tion with all the Land belonging to me on the South Side of
Dan River to my Son Lawrence freely to be Possessed and Enjoyed
by him — Also I Give to my Son Charles all that part of
my Plantation lying on the North Side of Dan River Joining
Noble's Land with his house & Saddle his Gun & one Cow &

Wash freely to be possessed & enjoyed by him - also I leave to my
Daughter Ribicai her bed and one cow and calf And the rest of
my personal Estate after all my Just Debts is paid I leave to be
Divided Equally between my other three Sons John Joseph & James
each of them to receive their part as they come of age - Also I leave
to each of my Daughters that is married (viz) Mary Osborn
Sarima Hansly, Elizabeth Cooke, Nancy Pierce, Frances Hansly
Sibela Hutching & Bertrice Hansly one Milling, Stealing, - And
I likewise constitute make and Ordain Sibela my wife and
Charles my son the sole Exec^r of this my last will and Testament
and I do hereby utterly disallow revoke and annul all and
every other Testaments wills Legacies & Exec^r by me in anywise
before made - Ratifying and Confirming this and no other to
be my last will & Testament. In Witness whereof I have set my hand
and seal this 17th Day of July 1773
