Sominger of the County of Surry, Province of North Carolina Carpenter
being Weakly in my Body, but of perfect mind & memory, than can
be given to God; calling unto mind the mortality of my Body, &
Knowing that it is appointed for all men Once to Die, do make
& Ordain this my last Will & Testament, that is to say, princ-
pally & first of all I give my soul into the Hands of Almighty
God that gave it; and my body I recommend to the Earth to be
Buried in decent Christian Burial at the Discretion of my
Executors: Nothing Doubting but at the General Resurrection
I shall Receive the same again by the mighty power of God
And as touching such worldly Estate wherewith it hath
pleas'd God to Bless me in this Life I Give & Devise to my
Truely Friend, for and in consideration of the love Good will
and Affection which I have & do bear towards ^{my} Coran

of the Same County & Province. Hereafter; for him to have
I to hold all and Singular my Goods, Money & Debts
for himself his Heirs & Assigns. Provided my Debts &
Funerall Charges being first paid by my Executor being
hereafter Named. Also I do Ordain to pay to my Only
Daughter Jacobina now living in the Province of
New England in the County of Powhatan Shesps. Got Town-
-Schipp one Shilling Sterling to be paid to her by my
Trusty Friend Jacob Bonn Esq. Whom I hereby do make
Ordain & constitute my sole Executor of this my will &
Testament. And I do hereby Disannull & make Void all
former Wills or Legacies either in Writings or by word of
Mouth by me formerly done Ratifying and Confirming
this and no other to be my Last Will & Testament. Witness
whereof I have hereunto set my hand & Seal this Seventh Day of
January in the Year of our Lord one Thousand Seven Hundred
& Twenty Seven
