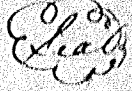


for and, in consideration of the sum of three hundred dollars also in

1805.

Sen^r of y^e State of North Carolina Surry County, being of
perfect mind & memory thanks be given to God. Therefore
calling to mind y^e mortality of my body & knowing that
it is appointed for all men once to dye, do make &
ordain this my last Will & testament & as touching such
Worldly Estate as providence has blest me with in
this life, I give devise & dispose of y^e same in y^e
following manner & form. ~ ~ ~ ~ ~

- First of all my Debts & funeral charges must be paid.
- 2^d it is my Will that my daughter Rebecca Patterson shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for her full share of my Estate
- 3^d it is my Will that my Son John Bohannon Jun^r shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for his full share out of my estate.
- 4th It is my Will that my daughter Elizabeth shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for her full share of my Estate.
- 5th It is my Will that my Son Alexander Bohannon shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for his full share ^{out} of my Estate.
- 6th It is my Will that my daughter Mary Bohannon shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for her full share out of my Estate.
- 7th It is my Will that my daughter Sarah Bohannon shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for her full share out of my Estate.
- 8th It is my Will that my Son Duncan Bohannon shall be paid out of my Estate by my Exrs^s y^e sum of ten shillings good money for his full share out of my Estate.

It is my Will that my plantation should be rented out & y^e Negros hired out & y^e other property put to interest for my Youngest Son Nial Bohannon, after my death.

- 3rd it is my Will that my Son John Bohannon Junr shall be paid out of my Estate by my Exrs^{rs} y^e sum of ten shillings good money for his full share out of my estate.
- 4th It is my Will that my daughter Elizabeth shall be paid out of my Estate by my Exrs^{rs} y^e sum of ten shillings good money for her full share of my Estate.
- 5th It is my Will that my Son Alexander Bohannon shall be paid out of my Estate by my Exrs^{rs} y^e sum of ten shillings good money for his full share ^{out} of my Estate.
- 6th It is my Will that my daughter Mary Bohannon shall be paid out of my Estate by my Exrs^{rs} y^e sum of ten shillings good money for her full share out of my Estate.
- 7th It is my Will that my daughter Sarah Bohannon shall be paid out of my Estate by my Exrs^{rs} y^e sum of ten shillings good money for her full share out of my Estate.

And it is my Will that

my Son Neal Bohannon shall be whole & sole heir
of all my real & personal Estate but what is above⁵³
mentioned, both of Land Negroes & other property.

Likewise I constitute make & Ordain my trusty friend
Simon Hadley Sen. & Bennet Smith my only & sole
Exec^{rs} of this my last Will & testament & do hereby
utterly disallow Revoke & disannul all & every other
former testaments, Wills & Legacies bequeathed & Ex^{rs}
by me in any wise before this time nominated
Wills & bequeathed ratifying & confirming this & no
other to be my last Will & testament. In Witness
whereof I have hereunto set my hand this 7th day
& year above written; Signed Sealed published
pronounced & delivered by the said John Bohannon
as his last Will & testament in the presence of us the
